#### **Arizona State Parks & Trails Fee Increase**

- SPRF (State Parks Revenue Fund) receipts have plateaued at approx. \$23.7 million annually
- The agency FY25 operating appropriation is \$19.2 million and the annual Major Maintenance allocation is \$3 million.
- Arizona State Parks receives no General Funds from tax receipts for operations.
- We are proposing a fee increase that will generate approximately \$7 million annually.



- In May 2018, the State Parks Board of Directors approved a range of statewide park fees that was formalized in the Arizona Secretary of State's Administrative Code.
- Fee increases now proposed are within the range approved in the 2018 Administrative Code.
- In general day use fees would be increased from a range of \$7-\$15 to \$10-\$20, camping from a range of \$15-\$40 to \$25-\$50 (some exceptions).
- Park fees have not been increased across the board for at least 12 years.
- Park operating costs are impacted by general inflation (approx. 40% over the last 12 years), staffing costs, equipment and facility maintenance.



- Statewide park improvements currently underway that will enhance the visitor experience include increased availability for water and electric hookups (30 & 50 amp), park broadband access, ADA improvements in facilities and trails.
- Infrastructure improvements to drinking water, wastewater and water conservation features.
- Fee changes not included in the Administrative Code:
- Riordan Mansion Tours Fees established when the park was operated by the Arizona Historical Society
- Adding a cancellation fee of \$10 (over 45,000 cancellations annually)



#### **Moving Forward with One Annual Pass**

- Discontinuing the \$75 Standard Pass (restricted access) continuing with one annual pass at \$200 (unrestricted access to all parks)
- The \$200 annual pass is within the approved price range and will provide unlimited access to all state parks with no restrictions.
- A standard pass (\$75) user who visits a park only once a week is paying just \$1.45 per visit versus the daily entry rate of \$10 per visit.
- A pass holder at the proposed rate of \$200 each who visits a park only once a week is paying just \$3.85 per visit versus the daily entry rate of \$10 per visit.
- A pass holder at the proposed rate of \$200 each who visits a park once a week with a carload of four is paying just \$0.96 per visit per person versus the daily entry rate of \$20 per carload of four per visit.

#### **Arizona State Parks and Trails Fee Increase**

- Potential Visitor Enhancements
  - Possible extension of hours of operation at day-use parks (e.g. Rockin' River Ranch)
  - Increase in park amenities (e.g. shade covers/ramadas, new restrooms, new trails, group camping areas, etc.)
  - Increased programming (e.g. guided hikes, interpretive walks, public events, additional Family Campout dates, etc.)
  - Increased staff (rangers, law enforcement, etc.)
  - Funding for future CIP projects (replacing ~\$50M in infrastructure that has been reverted the last two years)



#### **Arizona State Parks and Trails Fee Increase**

- Potential fee increases discussed with Operations leadership (with fiscal, IT and marketing)
  - Asst. Director of Operations, Chief of Operations, (3) Regional Managers
  - Discussed pros/cons for each park and its effect on visitation, operations and staff
- Park manager meetings
- Regional meetings
- New standardized park fee signage for all parks
- Talking points distributed to all park employees



#### **Arizona State Parks and Trails Fee Increase**

#### **Cancellation** Policy

- 45,495 cancellations equating to \$4,938,381 annually
- Consistent with other state parks (nationally) as well as federal agencies (USFS) and county parks (Maricopa)
- Primary intention is to modify behavior, not receive additional funding



#### **Arizona State Parks and Trails Fee Increase**

#### **Cancellation** Policy Business Rules

- Changes cannot be made if it exceeds 365 days from original date reservation was made unless change was required by ASPT. After the second change to a reservation any subsequent changes will result in a cancellation/refund and the customer will need to create a new reservation.
- Cancellations prior to 2 p.m. the day before scheduled arrival will be subject to a \$10 cancellation fee. Cancellations after 2 p.m. the day before scheduled arrival will be subject to a \$10 cancellation fee and will forfeit the first night's fees. Single night reservations cancelled after 2 p.m. the day before scheduled arrival will not be subject to a \$10 cancellation fee, all fees will be forfeit.
