Project: Upper Sullivan Canyon Acquisition

Upper Sullivans Canyon is a 10.5-acre parcel on the Upper Verde River lying between (and adjacent to) Arizona Game and Fish's Upper Verde River Wildlife Area and Arizona State Parks' new Verde River Headwaters State Park land at Sullivan Lake.

The property is already a popular rock-climbing area on the Verde River. For decades, many groups have used the property and its unique canyon for rock climbing, climbing instruction, and search & rescue training. The parcel also contains petroglyph sites, nesting owls, and a historic railroad bridge crossing the river gorge. The parcel would connect the new state park land to the Upper Verde Wildlife Area. Overall, this project would maximize opportunities for outstanding outdoor recreation and habitat protection including rock climbing at Upper Sullivans Canyon.

Project: Goodyear Community Park Dog Park Relocation Project

Goodyear's original Community Park opened in 2005 and is located at Litchfield Road and Indian School Road. This park annually attracts nearly 300,000 annual visitors and includes 36-acres of recreation amenities including: ballfields, splash pad, playgrounds, tennis courts, pickleball courts, sand volleyball courts, walking paths, skate park, interim dog park, restroom buildings, and maintenance building. Following an outreach process that gathered input from staff, stakeholders, user groups, and thousands of residents, the 2023 Parks and Recreation Master Plan identified relocating and expanding the interim dog park as a top priority.

This project will relocate and expand the existing dog park amenity to enhance safety and improve the overall user experience. Currently located adjacent to a ballfield, the dog park is being moved to the

northeast end of the park to eliminate safety concerns related to fly balls entering the dog area. Relocating the dog park not only addresses these safety issues but also allows for significant expansion. The new design will feature a larger space for dogs and their owners to enjoy, as well as the addition of amenities such as a dog agility course. This relocation and expansion will create a more enjoyable and secure environment for both dog park and ballfield users.

The eastern Santa Rita Mountains, part of Coronado National Forest, are a popular and high-use OHV area. In the 1990s, multiple OHV-related improvements in the Santa Ritas were implemented through AZ State Parks and Trails Grants. The decades-old signage is now missing, outdated, worn out, and/or illegible. With documented increase in OHV use since 2010 combined with the fact that Tucson and vicinity ranked highly in a survey of OHV users' favorite trails, it is essential to provide high-quality, on-site maps, as well as safety and responsible recreation information, for motorized recreationists in the Santa Ritas. This grant proposal focuses on two specific locations (pre-selected by Coronado National Forest) with existing single-panel steel frames (see photos in attached document), which will be restored to support new sign panels. Grant funds will be used to: (1) restore the existing steel kiosk frames; (2) develop a new, up-to-date map of the eastern Santa Ritas OHV routes; (3) develop bilingual, site-specific safety and responsible recreation information; (4) layout of both panels; (5) fabrication of new panels; and (6) panel installation.

Greenlee County has a population of approximately 9500 citizens, the county is approximately 120 miles from north to south and approximately 20 miles west to east, bordering the State of New Mexico. There are parts of many areas in the county that can only be accessed on foot, horseback, or OHV. From the beginning of spring through summer, at times during the weekends and Holidays, these areas get between 400 to 1000 OHV's entering and using these recreation areas. Greenlee County Sheriff's Office proposes to purchase OHV vehicles and equipment, to assist with enforcement of OHV laws, Game and Fish laws and Arizona traffic laws, for violations such as of driving under the influence (DUI), reckless driving, speed enforcement, criminal damage, trespassing, registration and licensing. It would also allow us to promote safety and education on the use of seat belts, helmets, eye protection, child restraints during active patrols of these areas. The funding requests also includes overtime to be paid to deputies for times of heavy OHV use in all areas throughout Greenlee County. Greenlee County Sheriff's Office would also attend events and fairs, providing literature and promoting safety and proper use of OHV's.

The town of Eagar's Round Valley Fire and Medical Department (RVFMD) determined that acquiring water rescue equipment is the department's top priority. Its service area includes multiple lakes, rivers, and reservoirs, making it critical to have the appropriate equipment to respond to water emergencies quickly and safely. To support RVFMD's mission statement—to protect and enhance the quality of life for residents and visitors through fire suppression, emergency medical services, and public safety education—the department seeks funding to purchase essential water rescue equipment. This will include a rescue boat, towing trailer,

personal flotation devices (PFDs), rescue bags, throw ropes, and other necessary tools to support safe and effective rescue operations.

The department will cover all costs associated with training and ongoing equipment maintenance to ensure both readiness and safety. Lakes and rivers in RVFMD's jurisdiction include Becker Lake, Lyman Lake, Nelson Reservoir, and Big Lake, which allow motorized use. With this investment, RVFMD will enhance its ability to protect lives and improve outcomes during water-related incidents.


The City of Yuma Fire Department is requesting funding for an emergency response equipment package to enhance firefighting, emergency medical, hazardous materials, and search and rescue activities along the lower Colorado River. The package includes, a fire suppression capable jet boat, two personal watercrafts with trailers, and a tethered Unmanned Aerial System (UAS). The jet boat and PWCs enable YFD to respond to the variable and shallow-water environments encountered along the Colorado River and its navigable waterways. Both are instrumental in locating and rescuing lost and distressed civilians. Similarly, they enable the fire district to locate and access areas of high fire risk along the river, with the ability to extinguish them using the jet boat's suppression system. The UAS requested platform is similarly essential to guiding fire suppression and search and rescue efforts along the river. The UAS would provide elevated observation with Forward Looking Infrared (FLIR) capability to enhance situational awareness during emergency operations on the river. The UAS would also enable greater operational efficiency in monitoring fire conditions along or on the river.

This project aims to enhance boating law enforcement and safety on the waterways of Navajo County by acquiring two fully operational patrol boats. The initiative will improve public safety, ensure compliance with boating regulations, and provide rapid response capabilities for emergencies. The grant funding will be used to purchase essential equipment required to make the patrol boat operational. This includes: Watercraft (boat),

Trailer, Motor, Radios, Lights, and Basic first-aid supplies This action is being proposed to address the growing need for effective law enforcement and safety measures on Navajo County's waterways. Increased boating activity has highlighted the importance of having a dedicated patrol boat to ensure public safety, enforce regulations, and respond to emergencies.

Project: Buckskin Mountain State Park Boat Launch Renovation






Arizona State Parks is applying for funding in order to renovate an existing boat ramp located at Buckskin Mountain State Park. The ramp has been closed for public use as it is unsafe for launching boats. In addition to renovating the launch ramp, funding will also be used to expand the existing parking area. The expansion will include additional ADA and boat trailer parking. The project will also develop an accessible path that will connect new ADA parking to lower beach area and new launch ramp.









2025 ASPT SUMMARY OF GENERAL LEGISLATION:

HB 2223: wind farms; construction; policy; procedures

Summary: Establishes requirements to approve, permit, construct and operate a wind farm. Requires the owner of a wind farm to obtain the approval of the state historic preservation office. The state historic preservation office shall issue an approval after review of all potential ground disturbances and proposed mitigations, including an assessment of any adverse effect or impact to cultural properties, national registered historic districts, archaeological sites and unmarked burial sites associated with the proposed wind farm project.

Update: The bill has not passed out of House, but it is still being amended.

HB 2275: income tax credit; historic preservation

Summary: Requires that the state historic preservation officer receive applications and evaluate and certify the substantial rehabilitation of a certified historic structure for the purpose of income tax credits.

Update: The bill did not receive a hearing.

HB 2775: community colleges districts; historic preservation

Summary: Currently, the statute does not make provisions for special governing districts-just state agencies. This Bill would add community college governing boards to the list of agencies required to consult with the State Historic Preservation Office.

Update: The bill did not receive a hearing.

HB 2868: preferential treatment; discrimination; policies

Summary: Expands prohibitions on preferential treatment and discrimination on the basis of race or ethnicity in public education, spending and hiring practices. Outlines prohibitions for the state or a state agency, a city or town, county, community college district governing board and a state university relating to diversity, equity and inclusion (DEI). Requires the state or a state agency, a city or town, county, community college district governing board and a state university to adopt policies that appropriately discipline an employee or contractor that engages in conduct that violates the prohibitions relating to DEI.

Update: The Governor has vetoed this bill.









HCM 2012: Antiquities Act; exception

Summary: Urges the U.S. Congress to enact legislation exempting Arizona from the Antiquities Act.

Update: The bill passed the Senate 17-12 and was transmitted to the Secretary of State's office.

HCR 2011: Arizona state parks heritage fund

Summary: Allows for \$10,000,000 to be deposited in the Arizona State Parks Heritage Fund from the lottery fund. Exempt from rulemaking for one year.

Update: The bill did not receive a hearing.

SB 1024: state agencies; payments; cryptocurrency

Summary: Effective January 1, 2026, authorizes a state agency to enter into an agreement with a cryptocurrency service provider to accept cryptocurrency as a payment method for any amount due to the state agency or the state. Allows tax payments to be made in cryptocurrency if the Arizona Department of Revenue (ADOR) enters into an agreement with a cryptocurrency service provider to accept cryptocurrency as a payment method.

Update: This bill passed out of the House 31-26 and was transmitted to the Governor. Governor vetoed the bill.

SB 1237: state employees; remote work; prohibition

Summary: Prohibits full-time state employees from working remotely.

Update: This bill passed out of Senate 17 ayes to 12 nays and is currently moving through the process in the House. Passed the House Regulatory Oversight Committee. Bill has stopped moving through the process.

SB 1243: open meetings; call to public

Summary: Requires that if a public body makes an open call to the public, the open call must be made at the beginning of the meeting and before the public body conducts any official business. If an open call to the public at the beginning of the meeting exceeds thirty minutes, the public body may choose to continue the remainder of the open call at a later time during the meeting. If a public body requires individuals to submit a request to speak before addressing the public body during an

open call to the public, the public body shall allow individuals to submit requests to speak until the open call to the public has concluded. If a public body posts a meeting agenda that only includes an open call to the public, that meeting may not be scheduled before or after another meeting of the same public body.

Update: This bill did not get a hearing at the House.

SB 1256: diversity; equity; inclusion; training; prohibition

Summary: Prohibits any state or an agency, board, commission or department of this state from using diversity, equity and inclusion programs for hiring, training or promotion purposes; or requiring an employee to engage in a diversity, equity and inclusion programs; or requiring, as a condition of a contract, participation in a diversity, equity and inclusion programs.

Update: This bill passed through the House 33-25 but was vetoed by the Governor.

SB 1267: veterans; lifetime state park pass

Summary: Requires ASPT to give free lifetime park passes to veterans who are currently residents of this state and have been for a year, submits evidence that they are veterans, and passes are also free for their passengers.

Update: This bill was assigned to Senate Government and Appropriations Committees but never received a hearing.

SB 1278: department of natural resources

Summary: Establishes the Department of Natural Resources (DNR) to oversee the acquisition and management of all non-trust state lands acquired after the bill's enactment, excluding any lands owned by a state university or the Arizona Department of Transportation (ADOT). The proposed DNR would have authority over any state permit relating to the extraction of natural resources.

Update: This bill has been stopped moving through the process.

1285: appropriation; wildfire readiness and response

Summary: Appropriates the sum of \$12,500,000 from the state general fund in fiscal year 2025-2026 to the Arizona department of forestry and fire management to award grants and an amendment was added in committee to appropriate \$250,000 from the state general fund in fiscal year 2026 to the Arizona Trail Fund.

Update: This bill will be considered in budget negotiations from the Senate.

SB 1418: outdoor-based therapy programs; grants

Summary: Establishes the outdoor RX program in the department of Health to provide grants for outdoor environmental, ecological, agricultural or natural resource-based or outdoor-based therapy programs serving the citizens of this state. Requires the Arizona State Parks Board to establish an advisory committee to assist and advise the department of health services in developing and administering the outdoor RX program.

Update: This bill was assigned to the Senate Natural Resources and Appropriations committees but never received a hearing.

SB 1517: off-highway vehicles; weight

Summary: Allows the Arizona Department of Transportation (ADOT) to issue a temporary general use registration, that allows an off-highway vehicle (OHV) to be operated for not more than 30 days, to a person who is a nonresident who owns an OHV titled in another state and otherwise meets OHV requirements. Extends the OHV study committee (study committee) by two years.

Update: This bill passed out of the House 41-11 and will be sent to the Governor's office.

SB 1678: state agencies; tribal liaison

Summary: Requires all state agencies in this state to employ a tribal liaison from a recognized tribe in this state to represent and facilitate communications between each state agency and tribal communities in this state.

Update: This bill was assigned to the Senate Government committee but never received a hearing.
