Chairman Larsen of the Arizona State Parks Board called the meeting to order at 9:59 am.

Pamela Cason did the role call. All members were present. Dale Larsen read the mission statement.

D. AGENDA ITEMS

1. Consideration of Action to Approve Minutes of the September 19, 2024, Board Meeting–*The Board reviewed the October 17, 2024 minutes but the motion was to approve the minutes from September 19, 2024. (This was a typo on the agenda)*

2. Office of Outdoor Recreation. Presentation on the objectives and priorities of this new office, focusing on its alignment with Arizona's SCORP (Statewide Comprehensive Outdoor Recreation Plan) to expand sustainable outdoor recreation opportunities for Arizona residents, our visitors, and future generations. (Presenter: Neil Large, Program Administrator of the Arizona Office of Outdoor Recreation)

Board Member Buchanan asked Neil if in his meetings with the confluence of states if they had discussed the use of OHV and the destruction they can cause and how we can continue to protect and conserve the outdoors and get the balance correct.

Neil stated that they had not discussed but some things that ASPT is doing is working with Appreciate AZ program and working with Tread lightly,. We have cataloged the trails throughout the state and put them on the ASPT website and continue to educate the public.

Member Buchanan is concerned that ranchers are closing their land off to hunters because of the people who are being destructive.

Director Broscheid said that we are continuing to talk to other states and figure out where we might be missing items. We will continue to network and have representation with groups like BLM, Forest Service and other local organizations.

Vice Chair John Sefton asked if this is a new position on the payroll or is Neil still doing both marketing and this new role. Neil stated that he is currently doing both roles.

3. Greater Sedona Collaborative Group. Southwest Decision Resources will provide a presentation on the OHV Grant Funded Greater Sedona OHV Management Facilitation Project. (Presenter:Mark Loseth, Southwest Decision Resources)

Vice Chair John Sefton asked how this project has been funded? It has been funded through grants and funding from ASPT

Member Buchanan is concerned about Coconino county sheriff's department is needing funding for resources. Matt Everhard came up and answered that Coconio made the decision to not put in an application but that he was happy to reach back out to his contact to see if they had changed their mind.

4. Growing Smarter Observatory Mesa Proposed Amendment to the Existing Observatory Mesa Right-of Way. The Arizona State Parks Board will consider and may take action on a recommendation to the proposed amendment of Right-of-way easement #16-88092 to enable the construction of an access road through Observatory Mesa Natural Area to private properties on the eastern side of Section 6. (Presenter: Mickey Rogers, Chief of Grants and Trails)

Cody Roudson, a homeowner, stood to make statement answer questions

Member Teri Palmberg asked if the homeowners lot sizes change. No, they stay the same. She asked who maintains the road. The homeowners. There will be an HOA formed for maintenance of the road. There will be a contract with the city of Flagstaff and the HOA road association.

Vice Chair John Sefton asked if the CIP tenure plan for either development for this space, use of or conservation. Robert Wallace, supervisor for the city of Flagstaff said that they are working on a trail plan which will go to the city council for final approval.

Member Teri Palmberg asked what the current uses are of the area, how much public access? There is a trail system that has 6 miles of trail but the trail plan would expand that. 30-35 thousand visitors per year access

Homeowner Joe Hendricks spoke to Member Palmberg's questions.

Vice Chair John Sefton made a motion to approve the right away easement change, Member Sarah King seconded the motion.

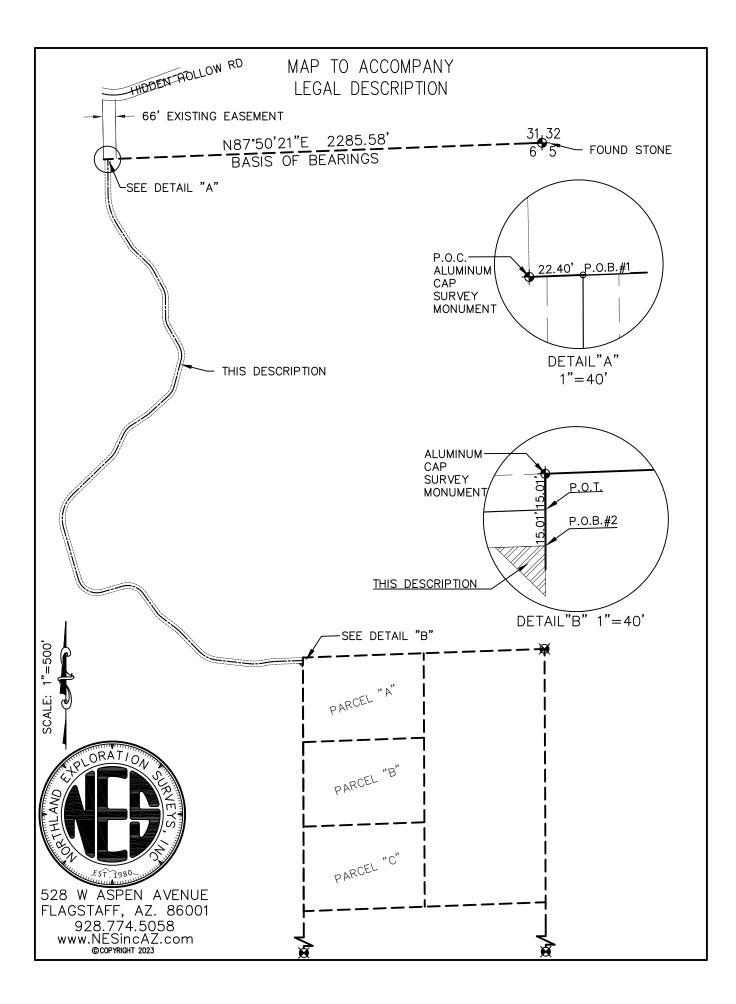

Installation of this culvert will open the road to most users and fire prevention. This area has suffered damage from rain due to the devastating fires we have had in the area. The contractor will install a culvert and stabilize the hill above the repair to keep the road passable for many years. This road is important for motorized recreation, hiking, hunting, ranching, and fire access.

The City of Prescott proposes the construction of a new trailhead, which will include a driveway, restroom facility, and parking lot with 22 standard, 2 accessible and 6 extended parking spots. The new trailhead will serve as a gateway to the Pioneer Parkway trail and greater Circle Trail system, and will also include information kiosks, seating areas, and signage to guide visitors. A new driveway will provide safe and direct access from Pioneer Parkway to the trailhead facility and will be designed to accommodate vehicles of all sizes, including vehicles with trailers. The proposed project will correct these issues. There has been a dramatic increase in use of the existing route, and improvements to this section are necessary to make the trail sustainable, and safe for users.

The first segment will develop 0.9 miles of FS Tr 294 in order to remove it from an eroding roadbed. Segment 2 will develop 2.8 mi of new trail in order to create a 5-mile loop, which will utilize 2.3 miles of Highline Trail, and portion of unnumbered "Old Highline" trail. Segment 3 will develop 0.72 miles of trail, which will move FS Trail 16 from a power line road. Segment 4 will develop 0.25 miles of trail to connect FS Trail #16 to a planned bike park and campground. Segment 5 will construct approximately 0.72 miles of Strawberry Mountain Trail. Funding will also be used to purchase a supply of quality trail tools for use on this and other projects. Finally, funding will be used to purchase and spread gravel on the existing Red Rock Spring Trail trail-head parking area.

Tonto National Forest is requesting funds to add approximately 6 miles of new class 3 non-motorized trails (1 loop will be built for adaptive trail users and 1 loop will be built as a mindfulness/nature trail) along with formally adopting approximately 10 miles of socially created class 3 non-motorized trails into the USFS trail network system. With this funding Tonto National Forest will hire a machine operator to build approximately 6 miles of new trail, while the local volunteers through Rim Country Mountain Bike association (RCMBA) will work on repairing and officially maintaining the socially created trails on the ground.

Funds are being requested to partially implement Phase I of the Red Rock Trails Access Plan (RRTAP), which applies to a 93 acre non-contiguous Forest Service parcel located next to Oak Creek School in Cornville, AZ. Cornville residents currently walk, bike and ride horseback on an old double-track road now closed to motorized traffic. This project would offer multi-use trail access in close proximity to Cornville residents with significant benefit to Oak Creek Elementary School students. The school has a robust outdoor recreation program, including mountain biking through FUN's program, with a bike skills park already on school property. A 3.02-mile trail would be constructed using mechanized equipment, and a 0.98-mile user created trail would be adopted on this parcel of Forest Service land adjacent to the Oak Creek Elementary School. In addition, a parking area would be constructed to accommodate up to four vehicles. Additional community access would be provided by the adoption of a short 0.08 user-created trail connecting to Fern Drive through property owned by Yavapai County.

Funding is being requested by the Prescott Mountain Bike Alliance to assist in developing additional phases of the Bean Peaks Gravity Flow Trail, which is a mountain bike-optimized, one-way trail containing berms, jumps and other engaging trail features. The purpose of this proposal is twofold. First, it provides unique trail opportunities that meet the increasing demand for a mountain bike-specific trail experience, which have been identified and prioritized through various collaborative planning efforts. Next, it will reduce user conflicts, many of which have derived from mountain bike users seeking a more specific "gravity/flow" trail experience that allows for higher speeds, banked turns, and more challenging opportunities that are not compatible with Prescott's multiuser shared trail systems. The trail will be developed through collaboration with the US Forest Service, the City of Prescott and Prescott Mountain Bike Alliance (PMBA). The proposed location is in Forest Service land approximately 4 miles north of downtown Prescott.

The Tonto National Forest (TNF) is proposing to conduct needed maintenance in the form of brushing, deadfall removal, cleaning existing drains, constructing new drains where needed, and minor tread work such as outslope armoring and removal of large rock from tread on trail #89 within the Mazatzal Wilderness to bring the trail up to standard from its current condition. Work will be conducted utilizing hand tools such as Mclouds, loppers, Pulaski's, and crosscut saws when needed. The trail maintenance will be performed from the bottom of the trail near Forest Road 479 and will end roughly 13 miles from this point at the junction with Trail 88 Sheep Creek.

The Boulders Area Trail System began as a loosely connected network of socially created trails on Tonto National Forest land directly southeast of Payson. The Rim Country Mountain Bike Association (RCMBA), a local International Mountain Bike Association chapter, will be contracting with an Arizona State Parks approved trail contractor to complete work. In total, there are 4 existing trails totaling approximately 8 miles. Work is required to refine the trail tread, and improve sustainability by installing dips, checks, and waterbars. Maintenance would also include removing vegetation, and eliminating hazards along the trail. Finally, some obliteration and restoration will be necessary in order to deal with the many off-shoots, as currently, the trail is confusing and has many dead-end options.
