#### **Land and Water Conservation Fund**

**Project Sponsor: Kingman** 

**Project: Lewis Kingman Park Improvement Project** 

Grant Request: \$450,400.00 Match: \$457,600.00 Total: \$908,000.00





The City of Kingman intends to complete is a renovation and development project to its Lewis Kingman Park, a 9-acre park which is located on Route 66 in Kingman. This park was originally a rest area in the early 1940-1950 which has transitioned to a park and is need of an upgrade. The proposed project will construct a new ADA compliant restroom to replace and remove an existing outdated restroom. The project will also install security lighting throughout the park, add electric services to the park, as well as to the open area for events and upgrade all three existing Ramada's in the park.

Project Sponsor: Show Low Project: Pickleball Courts Phase II

Grant Request: \$322,050.00 Match: \$322,050.00 Total: \$644,100.00





Funding is requested to expand its existing city Campus Park which currently has 4 pickleball courts. The use at these have been overwhelming and the proposal is to expand this to another 4 courts. In addition, funding will be used for a sidewalk, two ramadas, irrigation and landscaping. This will be matched with a Local, Regional and State Park Heritage Funding.

Joaquin Murrieta Park is over 50 years old with most amenities past their useful life expectancy. Thanks to the 2018 voter-approved proposition, Tucson will be improving Joaquin Murrieta Park and bringing elements up to today's standards. The phase 1 construction scope has been narrowed down to building a traditional clover leaf baseball/softball complex, a new restroom/concession building; one new playground with shade; new ramadas, new walking paths; lighting and a splash pad. This grant is specifically focused on funding for the splash pad to double the size of the play area. Since a pool cannot be built, the splash pad provides an opportunity for the community to enjoy a water feature in the park.

Project Sponsor: Lake Havasu City Project: City Park Development

Grant Request: \$1,000,000.00 Match: \$1,000,000.00 Total: \$2,000,000.00





Lake Havasu City proposes to develop a 1.5-acre parcel of land of open space to a city park. The City would like to develop this parcel as a public outdoor recreation facility, community gathering space and event space. The project will include ADA accessibility by including a drop off area that could be used by wheelchairs and strollers and an ADA accessible restroom. Picnic tables, shade structures, pathways and benches will be installed as part of this project as well as bicycle racks.

Arizona Elk Society's (AES) signature education programs provide the pathway needed to educate, recruit, retrain and inspire the next generation of outdoorsmen and women. This proposal requests the support for the following 3 major youth programs. Mesquite Wildlife Oasis, an outdoor classroom to provide an educational program to learn about Arizona's wildlife and ecology. Wild in the City is an outdoor skills day camp to introduce outdoor recreation and skills to youth that have had very little or no outdoor recreation. The Wapiti Weekend is a two day of outdoor recreation activities for youth. This event has roughly 50 volunteers providing 100 participants with varied outdoor activities. Funding will be used fishing poles, facility rental, camp supplies and educational materials and transportation. Funding will also partially fund an educational coordinator.

#### STATE LAKE IMPROVEMENT FUND

**Sponsor: La Paz County** 

Project Title: La Paz County Park Structural Upgrade

Grant Request: \$180,053.00 Match - \$0 Total - \$180,053.00





The La Paz County Park is requesting funds for upgrades after years of weather/erosion to the lagoon area and upgrade to our waterfront ramadas. Funds will be used to repair the pedestrian walkway and boat launch in the La Paz County Park Lagoon. Several events a year and thousands of guests use the lagoon for events. Funding request is also for a walkway over the water which is buckling and taped off from use, unsafe for pedestrians and people with disabilities. In addition, the boat launch is cracked and drops off dangerously at the end and funding will be used to remediate this issue. The final request is to purchase a 600-amp electrical panel and 2000 feet of electrical wire to complete the project that will bring electricity/pedestals to the waterfront ramadas at the Park. This was originally requested as part of an LWCF funded project but due to delays in the supply chain and the lack of matching funds, will use SLIF to complete the project.

**Sponsor: Buckskin Fire District** 

Project Title: Boat Launch Repair Project

Grant Request: \$215,150.00 Match - \$11,550.00 Total - \$226,700.00



The existing boat ramp located in Parker is failing. The funding will be used to make improvements to the existing docks, ramp into the river, and the existing parking lot which is in need of resurfacing including putting ADA striping in this area The final request is to purchase a new 300 HP motor which would be used for their rescue boat. Finally, the grant is requesting funding for signage that would be at the launch site with boating information along the River.
