The Timothy McKay Memorial Park is a passive park designed specifically to maintain greenspace in the middle of town, established from input provided by City Council and the Parks Advisory Committee. 





Arizona Office Tourism (AOT), Tread Lightly!, AZ Highways TV and Arizona State Parks & Trails are working to develop an Appreciate AZ campaign for the motorized community. This project funding (\$200,000) will be utilized to compensate Arizona Highways TV for the pre-production, development, and editing of a T.R.E.A.D. focused video series. The Arizona Office of Tourism will be matching this project 100% with \$200,000 which will be utilized for media buys and content creation. Videos will be utilized by all organizations (and future partners, including other state agencies) to better inform the OHV community about responsible use. Deliverables will include both short and long-form videos that can be shared across multiple platforms, examples are provided below:

#### **Supplemental Motorized Grants**

The City of Avondale has had an increase of calls for service related to illegal OHV, firearm use, and target shooting. There are approximately 3,268 single family homes and 3 businesses in the surrounding area that can potentially be affected by the illegal activities. Residents have reported rounds hitting houses nearby and large illegal OHV parties. The City of Avondale Police Department coordinates with other agencies such as Arizona Game and Fish, Bureau of Land Management, Phoenix Police Department and Maricopa County Sheriff's Office to perform education and enforcement. Patrols have been conducted using the Chevrolet 4x4 Tahoe which has periodically gotten stuck in the area due to the extremely soft sandy conditions. We currently do not have the appropriate equipment to be able to patrol the area. We are requesting \$100,000.00 funding for OHV equipment as it would be very helpful to keep up with the calls for service demand by patrolling more efficiently. Citations and education on OHV will help minimize illegal OHV activities. The main goal is to eliminate trespassing and illegal OHV which in turn leads to other illegal activities. Eliminating illegal OHV will make it safer for all involved, residents, officers, businesses, and the individuals participating in illegal activities.

#### **2024 GENERAL LEGISLATION:**

#### HB 2021: conservation easements; in lieu payments:

**Summary**: The holder of a conservation easement shall make an annual payment of monies in lieu of taxes on the reduction of value of the original parcel caused by the placement of the conservation easement. Payments shall be paid to the county treasurer of the county in which the real property burdened by the easement is located. Payments shall be distributed by the county treasurer to the county and to school districts, cities and towns in the county in the same manner as other property tax revenues. Retroactive from Dec. 31 to present.

Failed on the House Floor 19-36.

#### HB 2022: conservation easements; maintenance; weeds:

**Summary**: The holder of the conservation easement shall maintain the conservation easement property free of noxious weeds, Russian thistles (Salsola kali) and blowing dust that creates a threat to health or safety.

The entire bill was stricken with new language.

#### HB 2319: appropriation; heritage fund:

**Summary:** The sum of \$10,000,000 is appropriated from the state general fund in fiscal year 2024-2025 to the Arizona state parks heritage fund. The Legislature intends that the appropriation made be considered ongoing funding in future years. This appropriation is exempt from lapsing.

Never received a hearing.

#### HB 2593: public records; time frame:

**Summary:** Applies outlined requirements relating to a public records request time frame. Asserts that any entity that willfully or intentionally refuses to comply with the procedures for a public records request or otherwise acts in bad faith, shall receive a civil penalty of at least \$500 and at most \$5,000.

Passed the House and moved to the Senate, however, the Senate never heard the bill.





#### HB 2637: state lake improvement fund; drones:

**Summary**: Allows SLIF to fund the purchase of drones for: a) cleaning plastic, algae, biomass and other floating trash from lakes and waterways; b) search, rescue and recovery operations; and c) training for the use and operations of the drones. Requires the drones purchased to be equipped with: a) time stamped and GPS locating data sensors to provide constant monitoring of lakes and waterways; and b) collision avoidance. The bill also allows the governing body of a fire district to acquire monies from the SLIF to accomplish projects.

Passed the House and Senate and was transmitted and signed by the Governor. Governor signed and bill is Chapter 179.

#### HB 2750: motorcycle helmets; minors; citations:

**Summary:** Permits a law enforcement officer to issue a citation for a violation of not wearing a protective helmet to an operator or passenger of a motorcycle, all-terrain vehicle or motor driven cycle who is 16 or 17 years old.

Passed the House, but never received a hearing in the Senate.

#### HB 2804: tribal land acknowledgment:

**Summary:** Requires each public school, public university, community college, state or local park or library or other state or local government building in this state, in consultation with native American tribes, to display a native American tribal land acknowledgment plaque in a clearly visible location in a public area of the building that is readily accessible to the public.

Bill never received a hearing.

#### HB 2879: income tax credit; historic preservation:

**Summary:** Requires the state historic preservation officer to receive applications and evaluate and certify the substantial rehabilitation of a certified historic structure for the purpose of income tax credits. This is similar to the federal tax credit program.

Bill never received a hearing.

#### HB 2897: general appropriations act; 2024-2025:

Summary: Appropriates monies for the operation of the state government in FY 2025.

#### HB 2899: capital outlay; appropriations; 2024-2025

Summary: Makes capital appropriations, reductions and transfers of appropriations to state agencies in FY 25.

Budget Bill passed both the House and Senate and sent to the Governor.

#### HB 2902: environment;2024-2025:

Summary: Contains provisions relating to the environment needed to implement the FY 2025 budget.

Budget Bill passed both the House and Senate and sent to the Governor.

#### HCM 2008: urging Congress; Antiquities Act; repeal:

Summary: Urges the U.S. Congress to repeal or amend the Antiquities Act of 1906.

Memorial that passed both the House and Senate and sent to the Secretary of State.

#### **<u>SB 1005</u>**: public monies; ideology training; prohibition:

**Summary:** A public entity shall not: require an employee to engage in a diversity, equity and inclusion program. Spend public monies on a diversity, equity and inclusion program. Enter into or renew a contract with a company that participates in a diversity, equity and inclusion program. Spend public monies to acquire services, supplies, information technology or goods for a diversity, equity and inclusion program. Establish, support, sustain or employ an office or individual whose duties include coordinating, creating, developing, designing, implementing, organizing, planning or promoting diversity, equity and inclusion programs.

Passed the Senate, but did not pass the House.

#### **<u>SB 1045: public restrooms; feminine hygiene products:</u>**

**Summary:** Ensures that feminine hygiene products are provided at no cost in all women's and gender-neutral restrooms that are open to members of the public at each state park and historical monument in this state. Feminine hygiene products must be provided in a convenient and discreet manner. For the purposes of this paragraph, "feminine hygiene products" includes tampons, sanitary napkins and underwear liners.

#### SB 1052: all-terrain vehicles; definition:

**Summary:** Increases, from 2,500 to 3,500 pounds or less, the maximum unladen weight of an all-terrain vehicle.

Passed out of the Senate, but failed the House Floor 19-39.

#### **<u>SB 1055: off-highway vehicle study committee; extension:</u>**

Summary: Continues the OHV study committee for another year. Repeals on May 31, 2025.

Passed out of both the House and Senate and was transmitted and signed by the Governor. This bill is Chapter 76.

#### SB 1128: state agencies; payments; cryptocurrency:

**Summary**: A state agency may enter into an agreement with a cryptocurrency service provider to provide a method to accept cryptocurrency as a payment method of fines, civil penalties or other penalties, rent, rates, taxes, fees, charges, revenue, financial obligations and special assessments to pay any amount due to that agency or this state.

Passed out of Senate, but never received a hearing at the House.

#### **<u>SB 1176: appropriation; Arizona trail fund:</u>**

**Summary**: Appropriates \$250,000 from the state general fund in fiscal year 2024-2025 to the Arizona trail fund. The appropriation made is exempt from lapsing.

Passed out of the Senate, did not pass out of the House.

#### **<u>SB 1365: state agencies; cash payment; acceptance:</u>**

**Summary**: Each state agency or authorized agent of a state agency must accept cash and money orders to pay any amount due to that agency or agent or this state.

Passed out of the Senate, did not pass out of the House.





#### **<u>SB 1552: outdoor-based therapy programs; grants:</u>**

**Summary**: An outdoor RX program is established in the department of health services to provide grants for outdoor environmental, ecological, agricultural or natural resource-based or outdoor-based therapy programs serving the citizens of this state. Requires the Arizona state parks board shall establish an advisory committee to assist and advise the department of health services in developing and administering the outdoor RX program.

Never received a hearing.

#### **SB 1567:** off-highway vehicles; education requirement:

**Summary**: Establishes a driver's license and education requirement for the operation of an offhighway vehicle (OHV). Prohibits operating an OHV while consuming or possessing an open container of spirituous liquor.

Passed out of both the House and Senate and was transmitted to Governor.

#### SB 1725: state agencies; tribal liaison:

**Summary**: The Governor shall require all state agencies in this state to employ a tribal liaison from a recognized tribe in this state to represent and facilitate communications between each state agency and tribal communities in this state.

Never received a hearing.

#### SCR 1038: Arizona state parks heritage fund:

**Summary**: Allows this referendum to go to the voters and on proclamation of the Governor. \$10,000,000 shall be deposited in the state parks heritage fund from the lottery. The Arizona state parks board is exempt from the rulemaking requirements for one year after the effective date of this act. The Secretary of State shall submit this proposition to the voters at the next general election.

Failed in the Senate.
