# DRAFT MINUTES of THE OFF-HIGHWAY VEHICLE ADVISORY GROUP of THE ARIZONA STATE PARKS AND TRAILS

### A. CALL TO ORDER

Off-Highway Vehicle Coordinator Matthew Eberhart called the meeting to order at 1:02 pm.

#### **B. PLEDGE OF ALLEGIANCE**

OHVAG member Jeff Olson lead the Group in the Pledge of Allegiance

#### C. MEMBER ROLL CALL

State OHV Coordinator Matthew Eberhart tool roll call to confirm a quorum.

#### D. AGENDA ITEMS

- 1. Consideration of Action to Approve Minutes of the May 21, 2024 OHVAG Meeting.

  Member Olson moved to approve the meeting minutes from the May 21, 2024 OHVAG Meeting. Member Irwin seconded the motion. None were opposed and the motion passed unanimously.
- 2. OHVAG Will Consider and May Take Action on A Recommendation to the Arizona State Parks Board to Approve, Modify, Or Deny Funding for the submitted 2024 Competitive Motorized Grants Applications. (Presenter: Matthew Eberhart, State Off-Highway Vehicle Coordinator).

  Matthew Eberhart, State OHV Coordinator, provided members an overview of the La Paz and Mohave County OHV Education and Law Enforcement applications that were submitted. Member Headington asked for clarification on the issues that vehicle purchases and patrol hours would be used to address. Both agencies expressed that the vehicles and patrol hours would be used for OHV enforcement efforts in remote areas where their current fleet of trucks was unable to access. Mr. Eberhart reminded members and both applicants that the projects were ineligible for search and rescue, drug/alcohol patrols, and needed to be strictly used for the enforcement OHV Laws. Member Barlow also reminded members and meeting attendees that the Arizona Peace Trail crosses both project sponsors jurisdiction and that this project would be great to educate riders utilizing the trail.

Member Headington moved that OHVAG recommend that the Arizona State Parks Board approve funding for the submitted 2024 Motorized Grant Applications as follows; La Paz County Sheriff's Office OHV Law Enforcement and Education Program request in the amount of \$421,995.00. Member Olson Seconded the motion. None were opposed, Member Irwin abstained, and the motion passed.

Member Olson moved that OHVAG recommend that the Arizona State Parks Board approve funding for the submitted 2024 Motorized Grant Applications as follows; Mohave County Sheriff's Office OHV Law Enforcement and Education Program request in the amount of \$435,400.00. Member Headington seconded the motion. None were opposed and the motion passed unanimously.

3. Matthew Eberhart, State OHV Coordinator, provided members an overview of the amendment request for the Arizona Alpine Trail. Member Murphy asked what the additional funds would be used for specifically. Mr. Eberhart clarified that the funds would be used to increase an existing scope item related to on the ground research and trail data collection which would be completed by Logan Simpson, the contractor who is currently assisting AZAT with their Master Plan project.

- 4. State Parks 2025 Statewide Trails Plan. (Presenters: Deb Pryor, CEO, Partners in Brainstorm).

  Deb Pryor, CEO of Partners in Brainstorm provided OHVAG members an update on the trails plan survey and the process to date. Matthew Eberhart provided updates on the Partner Toolkit and Incentives Packages for survey participants as well as gave an overview of the timeline a head for getting the report finalized and
- 5. Emergency and Mitigation Supplemental Grant Application Update. (Presenter Matt Eberhart, State Off-Highway Vehicle Coordinator)

Matthew Eberhart provided an overview of the Cottonwood Spring Fencing project and the positive impact it will have long term on the environment and surrounding wildlife. Member Olson provided insight on Travel Management Plans from a USFS perspective based on conversations he and other members of the Apache County ATV club have had with the Apache Sitgreaves National Forest about having roads being converted to motorized trails as a way to keep them from closure and maintaining them as part of the motorized network.

The washout area requiring repair is approximately 3.4 miles from the north end of the trail and the gate at the forest boundary. The project will be to install a culvert at the major washout, and all materials for the installation of the culvert including back-fill. Installation of this culvert will open the road to most users and fire prevention. This area has suffered damage from rain due to the devastating fires we have had in the area. The contractor will install a culvert and stabilize the hill above the repair to keep the road passable for many years. This road is important for motorized recreation, hiking, hunting, ranching, and fire access.

The Off-Highway Vehicle Recreation Fund provides grant funding for Competitive and Supplemental Motorized Grant Applications. The current Supplemental Motorized Grants include Small (Trail Maintenance), Signage, Emergency & Mitigation, and Law Enforcement. In 2017, the Arizona State Parks Board Authorized the Grants and Trails Team to award Emergency and Mitigation Grants up to \$100,000 and Signage Grants up to \$10,000. # Tonto NF Travel Management Record of Decision

### **ROD** was signed October 5, 2021

This 10+ year NEPA process included public comment and a secondary Environmental Impact Statement to address all concerns. The final designation included:


- 1,378 miles of open roads & 2,265 miles of open motorized trails
- 8 OHV Areas (where cross-country travel is allowed)
- 4 OHV Area Tot Lots
- 4 OHV Permit Zones:
  - Bulldog Canyon (existing and predated this ROD)
  - Desert Vista
  - The Rolls
  - St. Clair

### **2005 Travel Management Rule**

The 2005 Travel Management Rule requires Forests to designate a system of roads, trails, and areas for motor vehicle use. These designated routes and areas will be displayed on a Motor Vehicle Use Map (MVUM).

### **Implementation**

- We're obligated to implement the 2021 decision in a timely manner. Our MVUM is almost ready for production, and we're moving forward with implementing permit zones one at a time.
- The ROD addresses the need for additional NEPA in some areas and trails, implementing in phases, and utilizing REA fees.
- Funding and resource limitations are slowing down the implementation process (it took 5,000+ volunteer hours to get St. Clair ready as a Permit Zone!).
- We're seeking additional support from partners and volunteers to help construct Tot Lots and OHV Areas to meet the requirements of the 2005 TMR and our 2021 ROD.





### 170 comments received via email/mail/story map








## Additional Notes about Comments Received

Many comments thought the fee was per permit zone.
Clarification: The proposal was to have one permit give you access to all 5 OHV locations. This gives the public access to much more area and for 1/5 the price!
Many comments thought only OHVs were being charged the fee and Jeeps, trucks, bicycles, or anyone else accessing the area would not be charged.
Clarification: Any motorized vehicle, regardless of size of vehicle or recreation activity after entering the permit zone, will need a Tonto OHV Permit. Users that walk, bike, horseback ride, or otherwise enter the area by means of non-motorized method will not need a Tonto OHV Permit. Also, vehicles parked in staging areas will not need a permit.
Most comments against the fee mentioned the existing Arizona State OHV tag fee and questioned why the Forest could not utilize the State OHV tag funds.
Clarification: The Arizona State OHV tag funding does not come directly to the Forest OHV Program. Forests can apply for grant funding through the State but approval and funding is never guaranteed, and that source of funding is not sustainable for the Tonto NF's popular OHV areas.
A lot of initial negative comments, but after providing public outreach and answering questions we received more positive feedback and suggestions on how to change the proposal to meet the public's needs.



## Summary of OHV SRP Proposal-Changes based on Comments



Top three things mentioned in comments:

- Fee cost was too high
  - We reduced our proposed rate and added a six-month permit option for winter visitors
- Fee per operator was unaffordable for families
  - We changed the permit requirement to per vehicle
- More Law Enforcement and patrollers in the OHV permit zones
  - With the fee system, we can do that!
- Honorable mention: better management and maintenance of the OHV areas



## **Additional Opportunities**

- 5 National Fee Free Days, with potential for more designated by the Forest
  - Martin Luther King Jr. Day
  - National Get Outdoors Day
  - Juneteenth
  - National Public Lands Day
  - Veterans Day
- The Forest and Region are looking into partnering with local libraries to provide recreation opportunities on the Tonto NF with the Cultural Pass
- Volunteers- fee waiver will be available for volunteers that have documented more than 40 hours of volunteer work in OHV areas on the Tonto NF or adjacent public lands
  - More details are in the Implementation Plan

 88% of the Forest's motorized routes remain outside of the Permit Zones and free to recreationists year-round





## Proposal → Approval

### April 25, 2024 AZ BLM Recreation RAC Presentation:

Tonto NF staff presented the Tonto OHV SRP fee proposal; RAC voted 7-3 to table the recommendation and requested additional info including Budget Plan with a list of planned facilities, answers to AZGFD questions related to the proposal, and an explanation of why the Tonto Pass or other existing passes could not be applied to the OHV Permit Zones.

### July 16, 2024 AZ BLM Recreation RAC Presentation:

Tonto NF staff presented additional information as requested; RAC voted 14-1 to recommend approval for the OHV SRP fee.

September 12, 2024 Regional Forester signed letter approving Tonto NF to proceed with implementing the OHV SRP fee proposal.
