## ARIZONA 2025 TRAILS PLAN SWEEPSTAKES

## **OFFICIAL RULES AND REGULATIONS**

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. HOW TO ENTER: To enter the Arizona 2025 Trails Plan Sweepstakes (the "Sweepstakes"), you must complete the 2025 Trails Plan Survey and elect to participate in the Sweepstakes by providing your contact information or mail a postcard or a card with your contact information to the designated address. Only one entry per person.
- 2. **SPONSOR:** The Arizona 2025 Trails Plan Sweepstakes is sponsored by Arizona State Parks and Trails (ASPT). Arizona State Parks and Trails is located at 1110 West Washington Street, Suite 100, Phoenix, AZ 85007 and can be reached via phone at (602) 542-4174 or via e-mail trailsplan@azstateparks.gov.
- 3. ELIGIBILITY: The Sweepstakes is open only to legal residents of Arizona who are 18 years of age or older on the date of entry. Directors, managers, and employees of Arizona State Parks and Trails (the "Sponsor"), members of the Arizona State Parks Board, as well as immediate family members and/or those living in the same household of each such person, and any others engaged in the development, production, execution, or distribution of this Sweepstakes (collectively the "Sweepstakes Entities") are not eligible to participate. "Immediate family member" shall be deemed to mean husband, wife, children, mother, father, sister, sister in-law, brother, or brother in-law. Sweepstakes may only be entered in Arizona or from the fifty (50) United States, the District of Columbia or Puerto Rico, and entries originating from any other jurisdiction are not eligible for entry. By entering the Sweepstakes, you are bound by and agree to these Official Rules. All federal, state, and local laws and regulations apply. Void where prohibited by law.
- 4. HOW TO ENTER: There are two (2) ways to enter:

(i) SURVEY ENTRY: Must visit the unique survey URL (the "Trails Plan 2025 Survey") and complete the survey. The survey must be completed by submitting all applicable answers to the survey questions. Upon completing the survey, the Entrant may be prompted to complete the entry form in its entirety to include first name, last name, street address, city, state, zip, phone number and email address (if available) and click "Submit." Entry form must be completed to be eligible to win. The survey must be completed by 11:59:59 pm MST on September 30, 2024, or by the date it is determined that the required number of surveys have been completed, whichever comes first.

(ii) WRITE-IN: To enter without participating in the survey, legibly handwrite your first name, last name, street address, city, state, zip, phone number, email address (if available) and date of birth and mail with proper postage to: Arizona 2025 Trails Plan Sweepstakes at Arizona State Parks and Trails, 1110 West Washington Street, Suite 100, Phoenix, AZ 85007. All write-in entries must be received by September 30, 2024. There is a limit of one (1) write-in entry per envelope/postcard per person. Each envelope/postcard is considered one (1) entry into the Sweepstakes. Multiple entries will not be accepted. Write-in entries

must contain all entry fields outlined above; otherwise, they are void and will not be eligible to win.

Regardless of the entry method used to enter the Sweepstakes, there is a limit of one (1) entry per person for the entire Sweepstakes Period. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant's entry and that Entrant may be disqualified from the Sweepstakes. Entries submitted by anyone other than the Entrant are void. In case of dispute as to the identity of any Entrant, entry will be declared made by the registered name and address on such entry. Any potential prize winner may be requested to provide Sponsor with proof that such person is the prize winner.

Neither Sponsor nor any Sweepstakes Entity is responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible.

5. PRIZES AND ODDS: Grand Prizes include two "Discover Arizona Parks Packages" (includes an Arizona State Parks Annual Day-Use Pass, and America the Beautiful National Parks and Federal Recreational Lands Annual Pass and an Arizona State Parks Park Store voucher) valued at \$205, two "PinDrop Paradise Escape Packages," which include a twonight stay in a PinDrop Travel Trailer at Dead Horse Ranch State Park or Lost Dutchman State Park and an Arizona State Parks Store voucher, each valued at \$340; the "Choose Your Own Adventure Package," which includes an America the Beautiful National Parks and Federal Recreational Lands Annual Pass, an Arizona Trail Association gift card, grocery store, outdoor retailer and gas gift cards valued at \$530; a "Gear Up and Get Out! Package" will receive outdoor retailer, multi-restaurant and gas gift cards, and Arizona Trails Association gift card and an America the Beautiful National Parks and Federal Recreational Lands annual pass valued at \$530; the "Newfound Fun Package" will receive a Visa, Ticket Master and gas gift cards and an America the Beautiful National Parks and Federal Recreation Lands Annual Pass valued at \$530; the "Culinary Curiosity Package" will receive multiple restaurant gift cards valued at \$450; the Flagstaff Arizona Hiking Outdoor Package" a three-night, four-day stay including lodging, a \$100 debit card and activities tailored to the winner's choice; the "Explore the Mogollon Rim Package" includes lodging for a three-day, four-night stay in Pinetop Lakeside, A \$100 debit card and activities tailored to the winner's choice. Additional prizes include books published by Arizona Highways, Day-Use Passes to Arizona State Parks (valued from \$3 to \$30), and various donations from Arizona State Parks and Trails partners (valued from \$5 to \$100). Odds of winning depend on the number of total eligible entries received. Gift cards may not be redeemed for cash. Gift cards may be subject to additional terms and conditions. Sponsor may, in its sole and absolute discretion, replace a lost, stolen, or malfunctioning gift card. - 6. **SELECTION OF WINNERS:** Ten winners will be randomly selected from among all eligible entries for the Grand Prizes. The drawings will be conducted no later than December 31, 2024. Drawings for smaller prizes including Day-Use Passes to Arizona State Parks and various donations will be conducted during the period from May 1, 2024 to no later than December 31, 2024.
- 7. WINNER NOTIFICATION AND ACCEPTANCE: Winners will be notified by 5 p.m. on January 6, 2025, by the Sponsor either via email, telephone, or mail. Failure of the winner to respond by January 20, 2025, may result in disqualification of winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner from among all remaining eligible entries. Once winners have been notified and verified, the Sponsor will mail the prizes to the address provided by the winner. Failure to claim the prize may result in disqualification of the winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner to range result in disqualification of the winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner from among all remaining eligible entries. Each prize winner is solely responsible for all applicable federal, state, and local taxes, including taxes imposed on his/her income. Winners may waive their right to receive prizes. Prizes are non-assignable and non-transferable. No substitutions are allowed. Prizes are subject to availability and Sponsor reserves the right to substitute prizes of equal or greater value. All stays must occur prior to January 6, 2026.
- 8. **PARTICIPATION:** By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes as solely determined by the Sponsor. In the event the Sweepstakes is compromised by a virus, unauthorized human intervention, tampering or other causes beyond the reasonable control of the Sponsor that corrupts or impairs the administration, security, fairness or proper operation of the Sweepstakes, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, Sponsor reserves the right to award prizes based on the entries received before the termination date.
- 9. **CONSTRUCTION:** The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
- 10. **WINNERS:** The decisions of the Sponsor regarding the selection of winners and all other aspects of the Sweepstakes shall be final and binding in all respects. Sponsor will not be responsible for typographical, printing, or other inadvertent errors in these Official Rules or in other materials relating to the Sweepstakes.
- 11. **DISPUTES:** This Sweepstakes is governed by the laws of the State of Arizona. In accordance with ARS § 12-1518, the parties agree to resolve all disputes arising out of or relating to this Sweepstakes through arbitration, after exhausting applicable administrative review except as may be required by other applicable statutes. As a condition of participating

in this Sweepstakes, participants agree that any and all disputes that cannot be resolved between the parties and causes of action arising out of or connected with this Sweepstakes shall be resolved individually, without resort to any form of class action, exclusively before a court located in Arizona having jurisdiction. In any such dispute under no circumstances shall participants be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than participant's actual out-of-pocket expenses. Participant further waives all rights to have damages multiplied or increased.

- 12. **RELEASE:** You irrevocably release and forever discharge the Sponsor and its directors, officers, affiliated entities, employees, partners providing Sweepstake prizes, the survey contractor, and other Sweepstakes Entities ("Released Parties") from any and all actions, claims, damages, liabilities and demands, whether absolute or contingent and of any nature whatsoever, which you now have or hereafter may have against the Released Parties, or their respective successors or assigns, arising out of or related in any way to use of your name, content, or anything contained therein.
- 13. **INDEMNITY:** You agree to indemnify, defend, and hold harmless the Released Parties from and against any and all claims, liabilities, damages, losses, costs, expenses, or fees (including reasonable attorney's fees) that any of the Released Parties may incur arising out of or related to the name, content, or your breach of these Official Rules. The Sponsor reserves the right to assume the exclusive defense and control of any matter otherwise subject to indemnification by you, and you agree to cooperate with the Sponsor's defense of such claims at your own expense.
- 14. USE OF DATA: Sponsor will be collecting personal data about Entrants online, in accordance with its Privacy Notice. Please review the Sponsor's Privacy Notice at <a href="https://azstateparks.com/privacy">https://azstateparks.com/privacy</a>. By participating in the Sweepstakes, Entrants hereby agree to Sponsor's collection and usage of their personal information and acknowledge that they have read and accepted Sponsor's Privacy Notice.
