2. REVIEW OF DELISTING OF NATIONAL REGISTER PROPERTIES

- a. The property at 2803 E. Via Rotonda has been significantly altered and therefore is no longer eligible as a contributor to the Sam Hughes Historic District in Tucson AZ. Pursuant to Federal Regulations (36 CFE 60:15) the Keeper of the National Register will be petitioned to remove the property from contributor status. With the delisting of the property it will no longer be eligible for the Historic Property Tax Credit and the County Assessor will be notified of the status change.
- b. The Phoenix/Mesa Gateway Airport has petitioned the removal of AZ U:10-61 (ASM) (Hohokam Land Use and Settlement along the Northern Queen Creek Delta MPS) Ordinance site in Mesa AZ from the National Register of Historic Places. The Keeper of the National Register will be petitioned to remove the property from contributor status.

3. REVIEW OF RECLASSIFICATION APPLICATION FOR PROPERTY IN ENCANTO MANOR

- a. The property at 825 W. Edgemont, Phoenix AZ does not currently qualify for the historic property tax reclassification because it is a non-contributor to the Encanto Manor Historic District. The HSRC will review current photographs and make a determination of eligibility.
