C. NEW BUSINESS

NEW NATIONAL REGISTER NOMINATIONS

- 1. Barrio San Antonio Historic District, Residential area roughly bounded by Manlove Street, Arroyo Chico, Park Avenue, and Santa Rita Avenue, Tucson, Pima County, Arizona**

Collins provided an overview of the Barrio San Antonio Historic District nomination.

After open discussion, the following recommendations were made by the Committee:

- The integrity analysis needs to emphasize feeling and association.
- Relationship between open space in Arroyo Chico needs to be emphasized.
- Period of significance needs to be justified. Clarity in dates needed. Why did it begin in 1912 and end in 1973?
- Photo captions need to give the style of the buildings featured.
- A table needs to be provided to show if the homes have a fence or shrine. What other features did they have?
- Provide census data to better support the neighborhood's evolution of ethnic heritage.
- Consistency in dates throughout the nomination needs to be checked. Hoerig believes the beginning date should be 1916, not 1912.
- Leonard would like to see the current National Register boundary on the map.
- Leonard would like to see more content about the infill and its relation to non-contributors.

E. SELECTION OF MEETING DATES FOR 2024

F. PROGRAM REPORTS

1. SHPO REPORT

a. National Register update, listings, property status, workflow -

Collins reported that since the July 14, 2023 HSRC meeting Properties Listed in National Register include: Coronado Neighborhood Historic District (Additional Documentation)

b. SHPO Staffing and Program News -

Leonard reported that SHPO has a Planner III position that is in the interview phase for an archeologist. Funding for the position comes from the US Forest Service. Konrad Howard's internship came to an end. Brian Forkum is beginning his internship with SHPO and will be working with the Site Steward Program. SHPO will hiring a new intern to continue Howard's work within the next couple of months. Funding for the position will come from the Bureau of Land Management.

c. Review and Compliance -

Leonard reported that Snowbowl is the one of the most review intense projects that SHPO is currently working on as of now. An upcoming project at Yuma Proving Ground will also be review intensive. SHPO has been dealing with program comments coming from various Federal agencies including the Department of Homeland Security and Army. Leonard explained that program comments are requests for exemption for Section 106 reviews. SHPO is closely following the BLM'S SunZia Transmission Line project which runs through southern New Mexico and Arizona. The project already as a record of decision and it is about to be implemented. Several tribes and Archeology Southwest have objected to the identification effort of Section 106.

d. Survey and Inventory -

Nothing to report.

e. Grants -

Lapota reported that the first round of Heritage Fund applications would be closing at the end of the day. Lapota expected five to eight applications to come in for the first round. The total for funding is \$1.8 million.

f. Legislative Issues –

Federal level – Nothing new to report.

State level – Leonard reported that there is a \$400 million shortfall for FY 2024 and \$600 million for FY 2025. SHPO is hoping to put the Site Steward Program into state statute.

g. HP 2023 Conference update –

Leonard reported that the 2023 HPC in Tucson had an estimated 300 attendees and that comments were very positive. Leonard reported that SHPO used the HPC to engage a focus group of stakeholders in a collection of data necessary for SHPO to produce the State Historic Preservation plan. SHPO is working with a consultant with Partners in Brainstorming for the state plan. The 2024 HPC will be in Prescott and in June.

2. AHAC REPORT

Majewski reported that AHAC did not have a quorum to have a meeting. Majewski reported that AHAC chair, Susan Shaffer, resigned for personal reasons.
