- 1. Consideration of Action to Approve Minutes of the April 28, 2022, OHVAG Meeting.

- 2. OHVAG Will Consider and May Take Action on A Recommendation to the Arizona State Parks Board to Approve, Modify, Or Deny Funding for The Submitted 2022 Motorized Grant Application(s). (Presenter: Matthew Eberhart, State Off-Highway Vehicle Coordinator) State Off-Highway Vehicle Coordinator, Matthew Eberhart presented an overview of all of the submitted 2022 Motorized Grant Application(s). Holly Irwin abstained from voting on the La Paz County Park Master Plan project. Chair, Todd Davis asked if the La Paz County Park project was separate of the previously proposed Bouse State Park/Staging Area from many years ago. Matthew Eberhart confirmed that the La Paz County Project was separate from that project. Chuck Wood moved that OHVAG recommend that the Arizona State Parks Board approve funding for the submitted 2022 Motorized Grant Applications as follows; Arizona State Association of 4 Wheel Drive Clubs, Information and Communication Grant Extension project in the amount of \$89,891.00, Tonto Recreation Alliance (TRAL), Tonto OHV Trail Management 2022 project in the amount of \$308,026.00, La Paz County, Bouse County Park Master Plan project in the amount of \$299,694.00, and Arizona State Parks and Trails, Greater Sedona OHV Management Collaborative Facilitation project in the amount of \$50,000. Jason Cobb Seconded the motion. Jason Cobb, Yes, Todd Davis, Yes, Pat Headington, Yes, Tom Murphy, Yes, Chuck Wood, Yes. Holly Irwin Abstained from La Paz County but voted to approve the Arizona State Association of 4 Wheel Drive Clubs (AS\$WDC), Tonto Recreation Alliance (TRAL) and Arizona State Parks and Trails. All 4 projects were recommended for full funding.
