# History of the Off-Highway Vehicle (OHV) Recreation Fund

# May 1989

 Governor Mofford signs SB1280 establishing governorappointed 7 member Off-Highway Vehicle Advisory Group and Off-Highway Vehicle Recreation Fund (portion of AZ Fuel Tax TBD)

## January 1991

- 1990 OHV Survey Report presented to legislature
- Proposed 1.747% of Fuel Tax (Approx. \$6M), received opposition

### June 1991

- Governor Mofford signs HB2093
  - 2 members added to OHVAG
  - Fuel Tax for OHV Recreation Fund set at 0.55%
  - 30% to be distributed to Game and Fish Department for Education, Law Enforcement, and Information
  - 70% to State Parks for Grants

# April 1996

Governor Symington signs SB1271 repealing OHVAG and

# May 1996

 Arizona State Parks Board (ASPB) re-establishes OHVAG as an advisory committee to the Board

# April 2006

 SB1508 establishes Copper Sticker OHV Management and Safety Fund to be administered by the Arizona Game and Fish Department

 Governor Brewer signs SB1167 initiating a user indicia fee (\$25 decal) program administered by the Department of Transportation to begin January 1, 2009

# April 2018

 HB2342 passes requiring a Non-Resident OHV Decal program to take effect by September 1, 2019

# **OHV Recreation Fund Revenue Sources Continued**

- ARS 28-5927: Fifty-five one hundredths of one per cent of the total taxes on motor vehicle fuel shall be transferred from the monies collected pursuant to section 28-5606 to the off-highway vehicle recreation fund established by section 28-1176 on a monthly basis.
- ARS 28-1177: D The director (ADOT) shall deposit, pursuant to sections 35-146 and 35-147, seventy percent of the user fees collected pursuant to this section in the off-highway vehicle recreation fund established by section 28-1176 and thirty percent of the user fees collected pursuant to this section in the Arizona Highway User Revenue Fund (HURF).








# **OHV Program Revenue Breakdown**

# **Arizona State Parks and Trails Role**


The Arizona State Parks Board shall spend 60% of the monies in the off-highway vehicle recreation fund for the following purposes:

- 1. No more than 12% for staff and managing the program
- 2. Develop an OHV Program based on priorities established in the OHV Recreation Plan
- 3. Design a grant program for the following:
  - To designate, construct, maintain, renovate, repair or connect off-highway vehicle routes and trails and to designate, manage and acquire land for access roads, off-highway vehicle recreation facilities and off-highway vehicle use areas
    - No more than 35% to be spent on new trails
  - To enforce off-highway vehicle laws
  - To provide informational and environmental education programs, signage, maps and responsible use programs
  - To prevent and/or mitigate damages to land and vegetation
  - To restore natural and cultural resources in the event of damage
  - To complete any necessary environmental, historical and cultural clearance or compliance activities

#### **Integrated Parks Reservation System Update**

#### **USeDirect Acquisition**

- USeDirect was recently acquired by Tyler Technologies a \$1.1B global digital government solutions company, publicly held and traded on the NYSE
- No impact to USeDirect Leadership, Operations or Park's Reservations System implementation
- Tyler Technologies brings a Significant increase in financial stability and personnel resources
- USeDirect is a Global company based in New York with Customers who operate in the US, Canada and New Zealand
- US customers are located in Maricopa County, Alabama, California, Florida, Oregon, Ohio, Pennsylvania, Virginia

#### **Temporary Delay to Future Reservations**

- Arizona State Parks and Trails has announced a temporary hold on future Campground and Tours reservations
- Effective March 18<sup>th</sup> no reservations beyond October 2<sup>nd</sup> will be accepted until after the system "Go Live" on August 1
- Shortly after "Go Live" reservations up to a year in advance will again be accepted

#### **Integrated Parks Reservation System Update**

#### **Temporary Delay to Future Reservations**

- The need for the temporary hold on future reservations is due to the migration of data to our new reservation system provider.
- By limiting advance reservations, we will decrease the amount of data that needs to be transferred, which will reduce double-bookings or lost reservations.
- This will also reduce the number of manual refunds required to be processed by the Central Office staff. For security reasons Credit Card information cannot be transferred from the previous vendor's database - All refunds for credit card based reservations made prior to the go live date must be processed manually (which takes longer).
- The hold on advance reservations will also result in a significant temporary reduction of revenue which should be recaptured when advance reservations are open again in mid-August.
- Overall Implementation is on schedule with an aggressive timeline for completion in late July.








## LYMAN LAKE STATE PARK

## PARK HISTORY

- First Recreational Park, 4th State Park for Arizona
- First signs of human occupation dates back to Basketmaker
   period 2-3,000 years ago
- Hopi, Zuni, and Anasazi all traveled through here
- First non-native occupants along the Little Colorado River settled here (Las Tusas)







## PARK HISTORY CONTINUED

- Buffalo herd used to be on the park, relocated in the 90's
- Yurts instead of cabins
- Museum Having one installed again in the Visitor Center
- Excavated pueblo left 3 rooms open for viewing
- Dam first built in 1911 second one built between 1919-1922, did improvements on it in the 80's/90's.








