

## SUMMARY OF LEGISLATION 55TH 2ND REGULAR SESSION:

#### HB 2038: state lake improvement fund:

Summary: Allows not more than 10% of monies to be deposited in the fund to fund staff support to plan and administer the fund. Removes the language to allow for monies to be used for administrative tasks and recreation plans of the board. Adds that monies in fund must be used also for water search and rescue operations.

The bill passed out of the House Chamber and passed out of the Senate Appropriations committee. This issue will be reserved for budget negotiations.

#### HB 2052: off-highway; recreation fund; annual report: THIS BILL IS A DEAD BILL.

Summary: Requires the annual report to be published on the Department's website. Currently the statute requires the report to be made available to the public, this bill just specifies where.

The bill passed out of the House Chamber.

#### HB 2130: recreational users; property:

Summary: The bill states that a user of a premises accepts the risks created by the user's activities and must exercise reasonable care in those activities. Exempts a landowner, easement holder, lessee, tenant, manager or occupant of private or public land from liability for damages in any civil action for unknown conditions on the land. States that installing a sign or other form of warning of a dangerous condition, use, structure or activity, or any modification made for the purpose of improving the safety of others, or otherwise failing to maintain or keep in place such a warning, does not create liability on the part of the owner if there is no other basis for that liability. States that statute governing landowner duties applies to the duties and liability of any governmental entity, nongovernmental organization or person that performs certain actions regarding land made available to the public for recreational or educational purposes. States that statute governing landowner duties does not create a duty of care or basis of liability for injury to persons or property. States that statute governing landowner duties does not relieve any user from any obligation that the user may have to exercise reasonable care in the user's activities on the land or from legal consequences for failing to employ such care. States that a user is liable to an owner for any damage to the land, property, livestock or crops that the user may cause while on that land.

This bill passed out of the House and Senate Chambers.

HB 2371: state agencies; cash payment; acceptance: THIS BILL IS A DEAD BILL.



## ARIZONA STATE PARKS & TRAILS

Summary: Requires that each state agency or authorized agent of a state agency must accept cash and money orders to pay any amount due to that agency or agent or this state.

This bill passed out of the House Chamber and was referred to the Senate Finance committee.

#### HB 2398: dude ranches; heritage trail program:

**Summary:** Establishes the Arizona Dude Ranch Heritage Trail Program. Authorizes the Parks Board to designate a dude ranch for inclusion in this program if it meets all specified criteria. Instructs the Board to decide on designation within 30 days of receiving an application. Directs the Board, in collaboration with the largest dude ranch or guest ranch association, to create signs and indicia a ranch can use to identify and promote its designation. Requires the applicant to pay for the cost of designing and creating the plaque. Stipulates that the Board allow additions or modifications to a designated dude ranch if its original character is preserved. Creates the Arizona Dude Ranch Heritage Trail, which consists of designated dude ranches.

The bill passed out of the House and Senate Chambers and was signed by the Governor.

#### HB 2412: open meetings; digital recordings:

**Summary:** Requires all public bodies to provide for both the taking of written minutes and provide for an audio or audiovisual recording of all public meetings, except for executive sessions, rather than requiring either the taking of minutes or a recording. Requires minutes to be posted online 3 days following the approval of minutes, rather than within 3 working days of the meeting. Requires any posting required for a meeting of a public body to remain on the applicable website for at least 3 years.

This bill passed out of the House Chamber and passed out of the Senate Government committee and Senate caucus proceedings. This bill is moving through the Senate and passed out of Senate caucus proceedings.

#### HB 2453: governmental entities; mask requirement; prohibition:

**Summary**: States that a governmental entity may not impose any requirement to wear a mask or face covering anywhere on the governmental entity's premises, except where long-standing workplace safety and infection control measures that are unrelated to covid-19 may be required.

This bill passed out of House Chamber and passed out of the Senate Government committee and Senate caucus proceedings. This bill is moving through the Senate and passed Senate committee of the whole proceedings.

#### HB 2498: COVID-19; vaccination requirements; prohibition:

**Summary:** States that a government entity may not require a resident of this state to receive a vaccination for covid-19 or any variant of covid-19.

This bill passed out of the House and Senate Chambers and was signed by the Governor.

#### HB 2587: public records; point of contact:

Summary: States that any entity that is subject to a public records request shall provide the name, telephone number and email address of the employee who is authorized and able to provide the information requested. This information shall be made available to the public on the website maintained by the entity. An employee who is authorized and able to provide information requested shall reply within five business days acknowledging receipt of the request.

This bill passed out of the House and the Senate Chambers. The Governor signed the bill.

#### HB 2611: vaccinations; masks; requirements; enforcement prohibition: THIS BILL IS A DEAD BILL.

Summary: States that any governmental entity or any person doing business in this state may not enforce on a student without parental consent or on an employee any requirement that the person receive a vaccination for covid-19 or any variant of covid-19 or wear a mask. A person who violates this section is guilty of a class 1 misdemeanor.

This bill did not receive a committee hearing.

#### HB 2753: executive session; public meetings: THIS BILL IS A DEAD BILL.

Summary: States that if an executive session is scheduled, a notice of the executive session shall state the provision of law authorizing the executive session and, in the case of legal advice, shall include the specific provision of 25 section 38-431.03 to which the legal advice pertains, and the notice shall be provided to the: 1. Members of the public body. 2. General public.

This bill did not receive a committee hearing.

#### HB 2760: historic preservation; tax credit: THIS BILL IS A DEAD BILL.

Summary: States that the Arizona state parks board shall receive applications and evaluate and certify the substantial rehabilitation of a certified historic structure for the purpose of income tax credits. (Lengthy Bill)

This bill did not receive a committee hearing.

#### HB 2789: Arizona trail fund; purpose:

Summary: Requires the Arizona state parks board shall administer the Arizona trail fund and the monies in the fund are continuously appropriated for the sole purpose purposes of constructing, maintaining and preserving the Arizona trail, including constructing, maintaining and improving water sources, signs, gates and public access.

This bill passed out of the House Appropriations and House caucus proceedings. This issue will most likely be a part of the budget negotiations.

#### HB 2831: state parks fees; exemptions; THIS BILL IS A DEAD BILL.

Summary: Requires a person who is an enrolled member of a federally recognized Indian tribe located wholly or partially in this state is exempt from admission fees, camping permit fees and park service fees of any state park.

This bill did not receive a committee hearing.

#### HCR 2019: Arizona's get outdoors initiative:

Summary: Requires Members of the Legislature to recognize that it is critical for the physical, mental and social well-being of Arizona's residents that the state promote healthy, active lifestyles filled with outdoor experiences of all types for Arizona residents, while respecting private property rights, etc.

This bill was unanimously adopted in the House and transferred to the Senate. This HCR did not receive a hearing at the Senate.

#### SB 1270: state parks; lottery; heritage fund:

Summary: States that out of the money remaining in the state lottery fund each fiscal year after appropriations and deposits, beginning in fiscal year 2023-2024 and each year thereafter, \$3,000,000 shall be deposited in the Arizona state parks heritage fund.

This bill passed out of the Senate Chamber. This bill also passed the House Land, Agriculture, and Rural Affairs committee and also the House Appropriations committee. This bill will be a part of the budget negotiations.

#### SB 1298: governmental mask mandate; prohibition:

Summary: States that a governmental entity may not impose any requirement to wear a mask or face covering anywhere on the governmental entity's premises, except where long-standing workplace safety and infection control measures that are unrelated to covid-19 may be required.

This bill passed out of the Senate Chamber. This bill was not given a hearing at the House.

#### SB: 1346: state employees; vaccination inquiries; prohibited:

Summary: States that any state agency or any contractor for this state may not send its employees to inquire about a person's vaccination status on a door-to-door basis.

This bill passed out of the Senate Chamber. This bill passed the House Government committee and passed the House caucus proceedings. This bill is still moving through the House.

#### SB 1377: Off-highway vehicles; fund; instruction; operation:

**Summary:** States that the Arizona state parks board shall spend fifty percent of the monies in the off-highway vehicle recreation fund for the following purposes: Not more than ten percent to fund staff support to plan and administer the off-highway vehicle recreation fund. Any designation or acquisition of land must be approved at a public meeting of the Arizona state parks board. At least ten percent for enforcement of off-highway vehicle laws. At least ten percent for state land lessee impacts.

Adds that in determining the amount of monies for eligible projects, the Arizona state parks board shall give preference to applications for projects that address impacts to state land lessees, for nonfederal projects, for projects where federal entities work with state and local entities.

Requires each agency to report the number and status of off-highway vehicle injury claims filed in the annual report. All off-highway vehicle operators and passengers assume all risks of personal injury or death associated with recreational use on public, state or private land. landowners and their authorized lessees do not have a duty to keep lands safe for entry and use by recreational users or to warn of or maintain lands and trails against unsafe conditions.

This bill passed the Senate Chamber. This bill passed the House Transportation committee but has not moved since.

#### SB 1405; state parks board; volunteers; fingerprinting:

**Summary:** Allows the Arizona state parks board to require volunteers who collect fees or interact with children or vulnerable adults within a state park to submit a full set of fingerprints to the board for the purpose of obtaining a state and federal criminal record check.

Allows the Department of Public Safety to exchange this fingerprint data with the FBI.

This bill passed the Senate and the House Chambers. The Governor signed the bill.

#### SB 1414: vaccine requirements; employers; prohibition: THIS BILL IS A DEAD BILL.

Summary: States that any government entity or any person doing business in this state may not require an employee to receive a vaccination for covid-19 or any variant of covid-19.

This bill did not receive a committee hearing.

#### SB 1558: appropriation; Little Colorado visitor center: THIS BILL IS A DEAD BILL.

Summary: Appropriates \$1,000,000 from the state general fund in fiscal year 2022-2023 to the Arizona state parks board to distribute to Navajo county to construct a Little Colorado River visitor center.

This bill did not receive a committee hearing.

#### SB 1559: state parks; heritage fund; lottery: THIS BILL IS A DEAD BILL.

Summary: States that out of the money remaining in the state lottery fund each fiscal year after appropriations and deposits, beginning in fiscal year 2023-2024 and each year thereafter, \$10,000,000 shall be deposited in the Arizona state parks heritage fund.

This bill did not receive a committee hearing.

#### SB 1596: off-highway vehicle study committee:

**Summary:** Establishes an off-highway vehicle study committee consisting of the Director of the state parks board or designee amongst others. The committee must meet to collect and study information from the public and stakeholders regarding ohv issues. The committee doesn't receive compensation. This committee is repealed on May 31, 2024.

This bill passed out of the Senate and House Chambers. The Governor has signed this bill.

#### SB 1670: state agencies; tribal liaison: THIS BILL IS A DEAD BILL.

Summary: States that the Governor shall require all state agencies in this state to employ a tribal liaison from a recognized tribe in this state to represent and facilitate communications between each state agency and tribal communities in this state.

This bill did not receive a committee hearing.


#### SCR 1010: Arizona's outdoors; recreation; supporting:

**Summary**: Requires Members of the Legislature to recognize that it is critical for the physical, mental and social well-being of Arizona's residents that the state promote healthy, active lifestyles filled with outdoor experiences of all types for Arizona residents, while respecting private property rights, etc.

This HCR was passed by the Senate and House Chambers and transmitted to the Secretary of State.

#### 2022 Motorized Grant Applications

Tonto National Forest: Cave Creek Ranger District – Travel Management Heritage Inventories
Funding Request – \$525,000.00
Project Score – 19









The Travel Management planning effort on the Tonto National Forest (TNF) requires that prior to posting any approved new routes or OHV areas on the Motor Vehicle Use Maps, archeological inventories and evaluations must be completed in accordance with Section 106 of the National Historic Preservation Act to identify and address any potential effects to cultural resources from motor vehicle use in these areas.

The scope of this project is to conduct archaeological inventories of all of the proposed new routes, approved OHV areas, and Tot Lots as required by the TNF Travel Management plan.

The TNF will use the funds to contract with a private cultural resources management firm to conduct the inventories and evaluations.

The TNF staff will review the results of the evaluations and conduct all the consultation with the Arizona State Historic Preservation Office and consulting tribes in an effort to complete all of the requirements of the National Historic Preservation Act. This will then fulfil the requirements of the Travel Management Plan and allow for the inclusion of the newly approved routes on to the Motor Vehicle Use Maps (MVUM).

This MVUM will be the starting point for managing motor vehicle use on the TNF and will allow the Forest to manage motor vehicle use to balance the use with protecting the natural and cultural resources, complying with applicable laws, regulations, and policies, and thereby providing for sustainable motor vehicle recreation opportunities.

Moving forward the TNF will be working collaboratively with partners and stakeholders on identifying future program and public needs for including repairs, reroutes, decommissioning, rehabilitation, facilities through future project planning efforts.

#### Arizona State Parks and Trails – River Island Staging Area Funding Request – \$2,003,442.00 Project Score – 15





RIVER ISLAND OHV TRAILHEAD MASTER PLAN

ARIZONA Design

Arizona State Parks is proposing to develop a new trailhead within River Island State Park in the vicinity of Parker in La Paz County, Arizona. The goal of the project is to provide Off Highway Vehicles (OHV) access to the mountain trails south of State Route (SR) 95. The land for the proposed development is owned by Arizona State Parks; no additional land acquisition will be required. The proposed project area footprint of approximately 21 acres. Under contract to Arizona State Parks, J2 Engineering & Environmental Design (J2) will develop a master plan for the project.

Project components will include construction of a day-use area, restrooms, parking areas, drinking fountains, camping and Recreational Vehicle (RV) spaces, shower facilities, shade structures, and signage; installation of new utilities—including water, sewer, and electrical—as well as construction of an on-site treatment facility for sewage and wastewater—also are planned. The site currently has several standing storage units and a convenience store/gas station, which will be removed as part of the project. Potential roadway modifications to existing SR 95 may be required to facilitate ingress and egress to the site.

## Cottonwood Police Department – Law Enforcement Equipment Funding Request – \$60,000.00





The Cottonwood Police Department will utilize the funds to purchase a side by side Off Highway Vehicle with emergency light package, police radio, and trailer for transporting the vehicle for the purposes of educating the public on Arizona Off Highway Vehicle laws and safety as well as enforcement of Arizona off highway regulations. We currently provide law enforcement on State Trust Land in Yavapai County, Coconino/Prescott National Forests, Dead Horse State Park, in conjunction with US Forest Law Enforcement, State Trust Land Investigators, and other local agencies like the Yavapai County Sheriff's Office. These are high volume Off Highway Vehicle areas partially due to the many Off Highway Vehicle Adventure rental companies in the area. In addition to OHV enforcement, we will utilize the purchased vehicle for public education on OHV regulations and safety while on patrol and at public events like National Night Out, Dead Horse State Park Verde River Days, and Thunder Valley Rally.

The vehicle can also be utilized for environmental clean-up of trash left behind by those utilizing our public lands in conjunction with an alternative sentencing community service work crew program.

Extreme temperatures, over exertion and poor judgement contribute to the need for emergency life-saving equipment and actions.


