1. NEW NATIONAL REGISTER NOMINATIONS

a. Sandra Day O'Connor House, Tempe, Maricopa County, Arizona - (05:40)

Collins provided an overview of the Sandra Day O'Connor House nomination.

MOTION TO OPEN DISCUSSION: (11:50)

Southard moved that the State Historic Preservation Officer place the **SANDRA DAY O'CONNOR HOUSE** on the Arizona Register of Historic Places at the **STATEWIDE** level of significance under **CRITERION B**, and that the nomination be forwarded to the Keeper of the National Register for placement on the National Register. The motion was seconded by Brooks.

Hugh Hallman was present to address questions, if necessary.

After open discussion, the following recommendations were made by the Committee:

- Need to remove reference to criterion C in the nomination.
- Stronger statement that O'Connor's selection of the site creates continuation of association.
- Question if the post and beam structure is non-contributing on page 9 needs to be clarified.
- Remove reference to "early phase," throughout the nomination.
- Clarification that the suggestion of Criterion G applies to the period of significance, not what comes after the period of significance.
- Remove references to architectural values.
- Create a more explicit discussion of other properties including the ranch and D.C. properties that are not eligible for association with Justice O'Connor.
- Using the word "regard" vs "significance"
- Addressing the criterion considerations together in the summary statement.

b. Jefferson Hotel, Phoenix, Maricopa County, Arizona - (42:40)

Collins provided an overview of the Jefferson Hotel nomination.

Roger Brevoort (preparer) and Geoff Beer (owner) present to address Committee questions.

MOTION TO OPEN DISCUSSION: (43:50)

Kupel moved to recommend that the State Historic Preservation Officer place the **JEFFERSON HOTEL** on the Arizona Register of Historic Places under **CRITERION C** at the **LOCAL** level of significance and that the nomination be forwarded to the Keeper of the National Register for placement in the National Register. The motion was seconded by Jacquemart.

After open discussion, the following recommendations were made by the Committee:

- More discussion about the buildings use by the City of Phoenix and its Barrister Place Building history.
- The significance statement needs to shift its focus from engineering to architecture and method of construction.
- Better explain how the building fits in Downtown Phoenix's early 19th century architectural traditions, which would be the rare, surviving example argument.
- The building's location, at the core of Phoenix at Central Avenue and Washington Street, is a key aspect of its integrity.
- The building reads as historic in terms of location, feeling, and association.
- Keep the C Criterion, but focus more on architecture, rare, surviving example, and strengthen what was going on at the time in Phoenix and what's remaining.
- The nomination would benefit from some additional information about the operation of the business that was there in the teens in Phoenix to include the fact that it was during a boom in construction of a particular type of material.
- Including images to express what was going on at the time the building was in its prime would be helpful.

The Chair called for a vote on the original motion, which was denied with a vote of 1-7. - (1:31:40)

E. STAFF REPORTS - (3:02:55)

1. SHPO REPORTS

a. National Register update, listings, property status, workflow -

Collins reported on recently approved and pending nominations at the Keeper's office. Deputy SHPO Cody discussed possible regulation changes.

b. SHPO Staffing and Program News -

Leonard reported that there is no new staffing news.

Leonard reported that there have been leadership changes at Arizona State Parks and with those changes there have been concerns with how cultural resources are managed by state agencies. SHPO has been working with the governor's office to look at our State Historic Preservation Act and our Antiquities Act to come up with some best practices. We are currently working with the governor's Transformation Office to do a Kaizen Process of how are records are managed, specifically our records for archaeological properties and inventory.

c. Review and Compliance -

Leonard reported that mining is a large part of SHPOs current workload in relation to Section 106, including The Resolution Copper and The Rosemont Copper projects. There is also a new expansion of a copper mine at Pinto Creek. Ft. Huachuca, Section 106, at the Mountain View Officer's Club is still occurring. There is new leadership at the fort and some of the commitments that were articulated through the Section 106 process for preserving and doing an adaptive reuse of that property are now in question. State Parks and SHPO applied for a civil rights grant for \$500,000 from NPS and there are issues with DOD being able to accept the grant monies because of a gift clause. We are working with the highest levels of the DOD and our congressional delegation to see if we can continue to move that forward.

SHPO is also working on a large-scale Conservation PA project with BLM for range improvement projects, similar to the existing NRCS PA, for project with little or no ground disturbance, which can be used by any of the other land management agencies.

d. Survey and Inventory -

Leonard relayed that there is nothing new to report.

e. Grants -

Leonard reported that the Mountain View Officer's Club grant SHPO applied for is stalled for the time being. Chris Cody is working with SHPO's partners at the Arizona Preservation Foundation and the Vail Preservation Society for rural community revitalization grant in hopes to save and rehabilitate the Vail Post Office.

f. Legislative Issues -

Leonard reported that two bills are moving through the Arizona State House and Senate, HB2701 and SB124, both bills would reestablish in statute the historic preservation focus of the Heritage Fund, which was lost previously. The House bill includes funding with the Arizona Lottery, but we would need to get in line behind everyone else in a nine-year cycle before that funding would be available. But, it does establish that the Arizona Lottery would be the source of funding for the Heritage Fund. The Senate bill is vague. It adds the fund back into statute, but doesn't provide for any funding. Jim McPherson reported to Leonard that the bills have come out of committee into rules. One of which will have to move appropriations. Then both bills will move to general caucus soon. The Heritage Alliance is asking of committee and any interested members of the public, to register at the automated system at azleg.gov to take a position on both of these bills. SHPO is still working with ADEQ with their proposed assumption of the Section 404 Clean Water Act Permitting.

Leonard reported that a bipartisan public lands bill was passed and signed by President Trump. The

bill permanently reauthorized the LWCF (Land and Water Conservation Fund). Leonard notes that she is well now and has been elected to the NSHPO board.

Cody discusses his recent trip to the NSHPO conference in Washington, D.C. He notes that AZ Rep. Raul Grijalva, who is the Chairman of the Natural Resources Committee, was the keynote speaker at the National Conference of SHPOs. Cody met with several members of Arizona's delegation including Senator Sinema, Representative Grijalva, Gallego, Gosar, Kirkpatrick and other staff members. He noted that there was a broad feeling of support with the people he met with at the conference. The two main requests raised at the conference were to increase Historic Preservation funding from \$49 million to \$60 million and to increase THPO funding from \$11 million to \$20 million. There was some discussion of new Historic Tax Credit Improvement Act that would look to undo the changes that were made to the tax credit. SHPO is in the process of a replacement for Arizona Archaeology Awareness month that would focus on K-12 educational programming. The possibility of permanently reauthorizing the Historic Preservation Fund was presented to Rep. Grijalva and he said he would support the move.

g. HP 2019 Conference -

Leonard reported that the HSRC has a session slotted for the conference. SHPO predicts that the conference will draw record attendance based on the number of people who have signed up so far. The Hassayampa Inn in Prescott, the location of the conference, has sold-out of rooms. There are plenty of other places to stay within walking distance of the hotel. The deadline is closed for receiving nominations for the Governor's Awards. We are currently looking for venues for the 2020 conference and a promising location could be Sierra Vista.
