- Construct a more concise, less academic definition of the term "critical regionalism," in Section 8
- Move section about Chafee's significance as an architect closer to the beginning of the nomination.
- Develop a proper context defining its exceptional significance

#### **E. STAFF REPORTS** - (2:22:49)

#### 1. SHPO REPORTS

## a. National Register update, listings, property status, workflow -

Collins reported on recently approved and pending nominations at the Keeper's office.

## b. SHPO Staffing and Program News -

Leonard reported that there is no new staffing news.

SHPO had a summer intern, Seth Vondy.

(Don Ryden leaves the meeting at 11:59 a.m.)

## c. Review and Compliance -

Leonard reported SHPO received notice from Customs and Border Patrol that they would invoke the environmental waivers on construction of the border wall along segments of the border in Cochise and Pima counties across National Parks Service and county lands. They will not be doing Section 106. Homeland Security notified SHPO that they will be consulting under their emergency provisions of Section 106 for certain judicial and dormitory facilities associated with ports of entry for hearings for those seeking asylum at the border. They will be consulting with SHPO for those improvements. SHPO has been working with Housing and Urban Development create streamline protocols with Programmatic Agreements at the both the city and county levels, including checklists and clarification of policy. SHPO has created a SHPO email address that centralizes all compliance for logging purposes into one email.

#### d. Survey and Inventory -

SHPO completed the Cemetery project, which took SHPO's entire cemetery inventory and digitized it and made it available through the Arizona Memory Project online. SHPO is looking to launch a similar project in 2019 which will digitize its Historic Properties Database, which will include inuse structures, and posted online possibly through a GIS database hosted by Arizona State Lands.

#### e. Grants -

Leonard reported that SHPO has received its HPF funds for this year. NCSHPO is working to ensure that the next appropriation of HPF funds is coming with a possible boost to SHPOs and THPOs. Mountain View Officers Club \$500,000 grant has stalled over what is considered a gift by the military. The military does not accept partial gifts and the grant will not put the club into service, so it is considered a partial gift. Arizona State Parks & Trails has appealed that decision at the instillation level. It will be sent to the Department of the Secretary. ASPT has sent a letter to the Department of the Secretary saying we intend to give this gift.

## f. Legislative Issues -

Leonard reported that there is a new HPF focus of the Heritage Fund. There are no monies in the fund, but the fund exists. The Arizona Heritage Alliance is planning to work with the legislature and possibly the governor's office to find funds.

# g. HP 2019 Conference report -

Leonard reported that the 2019 HPC was a success with nearly 400 attendees.

## h. HP 2020 Conference update -

Leonard reported that there will changes for the 2020 HPC. Conference planner, Dave Ryder, gave notice that he will no longer offer services for the HPC. For 2020, SHPO is looking to create a true

partnership conference with APF. They will be contracting planning services and SHPO will run the conference through APF, not the State of Arizona. SHPO also intends to reach out to Archaeology Southwest. SHPO would like the conference to be in Tempe for 2020 and is in talks with two venues for possible locations for the HPC.
