#### **1.** Service recognitions.

Matt Eberhart, State Off-Highway Vehicle Coordinator thanked and recognized John Geyer with a framed certificate of recognition for his service to Arizona State Parks and Trails and to Arizona's OHV Community in completing a 3 year term on OHVAG.

### 2. Veteran's Off-Highway Vehicle Ride.

Matt Eberhart, State Off-Highway Vehicle Coordinator discussed with members the 2019 ride and how we can work together to make 2020's ride more of a success and an even greater adventure.

### 3. Adamsville Emergency and Mitigation Grant.

Matt Eberhart, State Off-Highway Vehicle Coordinator shared with members an update on the Emergency and Mitigation Grant to fence off a cultural site near Florence, AZ that is being negatively impacted by OHV use.

# 4. OHV Industry advertising and marketing trends.

Matt Eberhart, State Off-Highway Vehicle Coordinator provided examples of current OHV industry marketing and the group discussed how to improve its OHV messaging towards responsible and recreational use.

### 5. State OHV Coordinator Updates.

Matt Eberhart, State Off-Highway Vehicle Coordinator informed the group that the "Show Me Ride" program would be included in the January 2020 newsletter that is distributed to over 100,000 people and are working to be more active on the Ambassador Facebook page. The group was also updated on the non-resident OHV decal sales which is currently over \$5,000 decals sold. In addition, the group was provided an update on "Show Me Rides" and their revised registration process and what information is currently on the State Parks website.

Todd and his group the Trail Riders of Southern AZ raised \$2,000 for the local food bank around this holiday season. Ben visited the Grand Canyon Parashant National Monument and could not identify any progress that should have been made on a grant they revived.
