Background:

The American Rescue Plan Act (ARPA) funding provides funding to assist facilities that were impacted during COVID. Statistically, the use of outdoor recreation nationwide increased over 20% during the peak of COVID. Outdoor facilities including local parks and trails provided safe socially distanced spaces for families and children to go during this pandemic. They also provided essential benefits to mental and physical health which is specifically defined in the Rescue Act guidelines. The focus of these funds at these facilities is for sewer/water upgrades, broadband and at facilities within neighborhoods in areas that have been identified as underserved communities. These funds are available loosely in the same categories as the appropriated Heritage Funds. A total of \$5,000,000 was made available for this program. These grants require no match and must be completed within two years of the funds being awarded. AORCC requested one project be tabled at their last meeting requesting more information at a future meeting.

Recommendation:

Arizona State Parks and Trails Grant Staff and the Governor's office reviewed this nonmotorized ARPA application and made recommendations based on ARPA eligibility.

2022 Heritage Fund Historic Preservation Grant Applications

Pima County - Pima County Office of Sustainability & Conservation Grant Request Amount: \$190,000.00

The Juan Santa Cruz Campground is a contributing resource to the Tucson Mountain Park Historic District that was listed on the National Register in 2021 as part of a Certified Local Government grant awarded to Pima County. The campground consists of a variety of architectural features that were constructed by the Civilian Conservation Corps in the 1930s. Pima County sponsored the development of a comprehensive master plan for the campground in 2020 that inventoried and documented the condition of all campground structures. Pima County is applying for this grant in order to fund the rehabilitation of these important structures in order to preserve the legacy of the CCC and their outstanding contribution to recreation in Tucson Mountain Park.



Vail Preservation Society - 1908 Old Vail Post Office Rehabilitation Grant Request Amount: \$249,600.00

The 1908 Old Vail Post Office (OVPO) is Vail Arizona's oldest building. This site has connected residents through commerce since 1888. The OVPO's adaptability over the 20th century made it a nexus of human connections and commerce. Through rehabilitation and adaptive reuse, the OVPO will be a HUB for the greater Vail community in the 21st century as the Vail Welcome & Heritage Center, a gathering place for residents and visitors, and HQ for Vail's AZ Main Street program. It will be a visual reminder of Vail's railroad and ranching roots while filling current and future needs. Rehabilitation work will involve foundation underpinning, adobe stabilization and repair, exterior lime plastering, replacing the buildings' roof including the addition of interior structural roof supports, restoration of 8 windows, 4 doors, electrical, and ADA compliance.



Stratford Art Works, Inc. - Teatro Carmen Rehabilitation Grant Request Amount: \$300,000.00

The 1915 Teatro Carmen Theatre in Barrio Viejo is currently undergoing a rehabilitation to return it to its performance roots as a 250-seat cultural arts venue. The total project cost is approximately \$4.5 Million, and is being done in two phases. Building stabilization and an adjacent outdoor performance space development along with a facade restoration in phase 1, and phase 2 will the interior rehabilitation. This grant would be for the facade work and will be matched by Pima County dollars and private foundation grants.



City of Prescott Historic Preservation Office - Update of Historic Preservation Master Plan and Homeowner Guide

Grant Request Amount: \$60,000

Update to the Prescott Historic Preservation Master Plan including additions of new districts, public engagement, removal of outdated information and streamlining of plan document and digital formats. This project also includes a minor update of the Historic Homeowners Guide (based on the Master Plan) and a reprint of those booklets that are made available to the public.

City of Tucson Housing Department - Historic Ft. Lowell Rehabilitation Grant Request Amount: \$300,000.00

Over the years, the City has acquired, and fenced in, parcels relevant to the interpretation of the Fort. This Rehabilitation Project will open the important histories of Fort Lowell through: rehabilitation of the Fort Commissary-turned-apartments, interpretive signage and walking path; site markers indicating locations of Fort facilities no longer standing; preservation of, and protective cover for, the Fort Hospital; restoration of Officer's Quarters 3 Interior to make available for docent-led tours; and restoration of Cottonwood Lane. In combination with current City funding sources used in these efforts and beyond, the Historic Fort Lowell Rehabilitation Project will welcome the casual and the expert visitor with opportunities to deepen their sense of place and the scope of military operations in the Tucson area. This Grant will fund construction at the Hospital, in Officer's Quarters 3, along Cottonwood Lane, and a portion of the Infantry Barracks Ramada.



2022 Heritage Fund Non-Motorized Trails Grant Applications

TRACKS, Inc. - White Mountain Trails System (WMTS)

Grant Request Amount: \$59,125.00

Purchase and install 43 bike/hike ramp gates on the White Mountains Trail System (WMTS), a 200+ mile non-motorized trail system in the US Forest Service Lakeside Ranger District of the Apache-Sitgreaves National Forests. All major trails of the WMTS are loops, with connector trails forming a trail system. There are many areas across the Lakeside district that are fenced for cattle grazing, so installation of these ramp gates will improve and facilitate trail usage of hikers and mountain bikers, as well as keep cattle secure since users often forget to close gates. The ramp gates will be installed in fence lines next to existing gates that have been in place for years. Thus, hikers and mountain bikers will have an option for crossing fence lines without having to open/close a gate. Project Timeline: 4/1/2022 begin gate installation, May-Oct continue installations; 2 per week until completed.



National Forest Foundation - Santa Catalina Trails: Rehabilitation after the Bighorn Fire Grant Request: \$100,000.00

The National Forest Foundation (NFF) proposes a 2-year project to rehabilitate 7 non-motorized, multi-use trails on the Coronado National Forest. These are popular trails in the Santa Catalina Ranger District—receiving over a million visitors each year. The trails were heavily damaged in Summer 2020 by the Bighorn Fire, which burned nearly 120,000 acres of the Santa Catalina Mountains. The following summer's extreme monsoon season resulted in flooding, washouts, and heavy vegetation growth, exacerbating damage. Using volunteer labor along with a skilled

crew, NFF will work with the Coronado National Forest to re-open these trails, many of which remain closed to protect public safety and the natural environment.



2022 Motorized Grant Application(s)

Town of Camp Verde - Box T Remediation Request Amount: \$106,017.00

Box T is a trailhead located on Prescott National Forest land identified in the Verde Trails and Access Plan as a multi-use trail. The trailhead is not formally developed and therefore the trail access point is subject to periodic damage. Motorized use when the natural ground is wet has led to the deterioration of the natural landscape and left rutted out tire tracks. The "trailhead" is located on an unsafe blind curve on Salt Mine Road, making access to the trailhead difficult and unsafe. The project is being pursued in order to correct the continued deterioration of the trail access point and to enhance safety.



2022 State Lake Improvement Grant Applications

La Paz County Sheriff's Office - La Paz County Sheriff's Office Waterway Safety Center Improvement

Request Amount: \$30,128.00

The La Paz County Sheriff's Office Waterway Safety Center is now 26 years old and in desperate need of having its HVAC system replaced. The Waterway Safety Center is a working office for the La Paz County Sheriff's Office, Arizona Game and Fish Dept, BLM and the San Bernardino County Sheriff's Office who all share the responsibility of patrolling the Colorado River in La Paz County. Air Conditioning is vital to this office for all personnel who work the Colorado River in La Paz County and for the equipment inside this center, such as Intoxilyzers which are

not a heat tolerating instrument. This grant is to remove all HVAC equipment in the center and replace it with new.



2022 American Rescue Plan Act (ARPA) Non-Motorized Grant Application(s)

Sierra Vista ADA Shared Use Path Request Amount: \$100,000.00

The City will be awarding a contract to construct an ADA compliant 120 space parking lot, in the upcoming days. This parking lot will support activities associated with Cyr Park. In an effort to both aid in the connectivity from said parking lot to Cyr Park and an existing SUP (just south of the proposed parking lot); an ADA compliant shared use path design has been produced and is shovel ready. ARPA Funding for this shared use path the construction of this path would provide a physical area to safely recreate for pedestrians

and cyclists. This Path will also serve to improve both the physical and mental health of residents in these Qualified Census Tract Areas through their newly acquired ability to access additional outdoor activities and experience less confinement due to the many restrictions imposed through the COVID pandemic.





- Addresses all types of outdoor recreation, across all types of providers, across the state.






