## Motorized - Bureau of Land Management - Travel Management Requested Amount - \$412,969.00


BLM AZ is requesting grant funding to develop 4 Travel Management Plans (TMPs). The 4 TMPs will cover approx. 2,655 trails/routes miles in three (3) BLM districts (Colorado River, Gila, and Phoenix District offices). These plans will identify and authorize trails/routes to maintain, develop and manage that address public input, protect natural and cultural resources and result in sustainable recreational motorized (jeeps, atvs, utvs, dirt bikes, etc.) and non-motorized (hiking, biking, equestrian, etc.) access and opportunities. These Plans will produce authorized large-scale maps that will form the foundation for digital and print maps, signage, more accessibility, and information kiosks. TMP development will include teams of BLM specialists and contractors evaluating routes, utilizing NEPA, providing cultural and biological assessments, to establish TMP designations, and organize and respond to public and stakeholder comments and concerns. BLM AZ recognizes that socio-economic issues related to travel planning are becoming more important. To ensure that these issues are taken into consideration in travel management planning, BLM AZ will coordinate and collaborate with adjacent landowners, communities, agencies, private, local, state, federal, and other interested stakeholders.






## Heritage LRSP – City of Buckeye – Sundance Park Phase II Requested Amount - \$500,000.00

The City of Buckeye is requesting a Heritage Fund grant to construct a portion of Sundance Park Phase II. The grant and City match will construct two lighted multi-use fields, including grading and sand base, irrigation, turf, and Musco sports field lighting. The City of Buckeye is nearing completion of construction plans for Phase II of the park. Phase II of the park is located on 38-acres west of the existing 30-acre park, which opened to the public in 2012 at the southwest corner of Lower Buckeye Road and Rainbow Road. Separate from this grant, and as part of the initial development of Phase II, the city will be installing a 3.2-acre community fishing lake, splash pad, playground, basketball courts, and other amenities. The multi-use fields to be constructed as part of the grant and City match are the next improvements to be constructed. Multi-use fields are highly desired by Buckeye residents as seen through public input opportunities.





## Heritage SLIF – Bullhead City Police Department – Rouge Jet Boatworks Requested Amount - \$106,000.00

The money received will be used by Bullhead City to purchase one (1) new patrol boat. The boat will be purchased from Rogue Jet Boatworks. The purchase of this boat using monies from the grant will greatly reduce the budgetary strain for the Bullhead City Police Department and allow us to expand our fleet at considerably less cost and increase public safety on our waterway. It will allow us to replace our aging vessels that are at or approaching end of life and continue to provide continual service on the water.





## Heritage SLIF - Lake Havasu City Police Department - Public Safety Boats and Equipment

## Requested Amount - \$800,000.00

The Lake Havasu City Police Department is requesting funds to purchase a new boat and two replacement motors to enhance our aging fleet. The primary purpose for a new vessel would be to ensure boating safety through the Bridgewater Channel and on Lake Havasu by enforcing Arizona and Lake Havasu City boating laws and ordinances. Our department actively participates in dive rescue missions and training in conjunction with Mohave County Sheriff's Office and San Bernardino County Sheriff's Office. None of the current boats in our fleet are practical platforms for conducting emergency, life-saving dive rescue missions. The requested replacement boat would allow our dive team a faster response to emergencies by providing the capability to carry all of the dive gear and personnel while responding to remote and hard-to-reach areas. Replacement of two high power motors on one of our current boats is also needed. Replacement of these motors will ensure reliability and extend the useful life of the vessel, and mitigate increasing maintenance costs.

The Lake Havasu City Fire Department requests grant funding to replace its fifteen-year-old Munson Fire Rescue Boat and boat lift. As one of only two fire departments that respond on the Arizona side of the lake, the boat has been utilized on multiple incidents. Unfortunately, it is nearing the end of its service life and is in need of replacement. The new boat will be a thirty-foot modified v-hull landing style craft equipped with twin 300 HP outboard engines. It will be equipped with modern navigational electronics, a fire/marine band radio system, and a 1000 GPM fire pump. The Department will also replace the existing boat lift system to accommodate the new boat.
