


Summary of the Arizona Trail Fund (A.R.S. § 41.511.15),

- 1) Established legislative appropriations and donations to the fund.
- 2) Monies in the fund are continuously appropriated for the sole purpose of maintaining and preserving the Arizona Trail.
- 3) State Parks works with the Arizona Trail Association and other partners to approve funding for projects that best meet the needs of the Arizona National Scenic Trail and comply with the statutory intent of the legislation.
- 4) In 2007, the first year the fund was established, the legislature appropriated \$250,000. In the next two years \$125,000 was appropriated for each year. However, in mid-2009 the State Legislature rescinded all unused funds.





